I, BRANDIE MARILYNN BOUMA, of Devon, Alberta, MAKE OATH AND SAY THAT:

- 1. I am the separated spouse of Nicholas Francis Bouma. I have personal knowledge of the following except where stated to be based on information and belief.
- 2. I swear this Affidavit in response to being served by the Application of 1220201 Alberta LTD. to appoint an interim receiver. My counsel was served with this application on August 26, 2025 at 6:30 pm. My counsel advises that she consulted with Bren Cargill at Witten LLP the following morning, who is knowledgeable in this area of law. She advises that Mr. Cargill could be available on September 8, 10, 11, and 12, 2025 to speak to this application as her agent. I am swearing this affidavit to provide the court with some background of the family law matter under court file number 4803 191526.

Background

- 3. Nicholas Francis Bouma, (the "Father") and I were in a 17 year relationship. We began to live together in February 2003, we married on September 15, 2012, and we separated on April 6, 2020. My statement of claim for divorce and division of family property was filed on August 11, 2020.
- 4. There are currently two children of the marriage, and one former child of the marriage namely:
 - a. Landon Nicholas Bouma, born February 16, 2003 ("Landon").
 - b. Blake Richard Bouma, born October 21, 2008 ("Blake");
 - **c. Chase Perry Bouma**, born February 19, 2014 ("Chase)

(collectively "the Children").

5. Landon is 22 years old and has not resided with either party since separation; he is not attending school. Blake is 16 years old and currently resides with the Father's parents. Blake has parenting time with me every second weekend. Chase is 10 years old and lives primarily with me.

- 6. I was a stay at home mother during the marriage. I now work as a full-time educational assistant at Christ the King School in Leduc. I earn \$22.77/hour; my net monthly income is \$2,468.33.
- 7. The Father owns a butchery business, called Edmonton Custom Packers, from which he earns income. He was the primary breadwinner during the marriage. My understanding is that the Father is the sole shareholder and director of the business and that there are various companies involved in his ownership. The Father is the sole director and shareholder of 1832066 Alberta Ltd. This company is the sole shareholder of E.C.P. HOLDINGS (2014) LTD; the Father is the sole director. E.C.P. HOLDINGS (2014) LTD is then the sole shareholder of EDMONTON CUSTOM PACKERS LTD.; the Father is the sole director. Attached hereto and marked as Exhibit "A" are the first 3 pages corporate searches for these three companies.

Streamlined Trial

- 8. The family law matter under court file number 4803 191526 is set for a Streamlined Trial on September 16 and 17, 2025. The Father has not participated in the litigation since his counsel withdrew in July 2023.
- 9. Attached hereto and marked as **Exhibit "B"** is a copy of the Streamlined Trial Hearing Order granted by Justice Angotti on July 29, 2024. My counsel advises, and I believe it to be true, that the Father has been properly served with notice of the Streamlined Trial and all subsequent documents pursuant to paragraph 24 of the Order. The Streamlined Trial dates were confirmed on August 9, 2024. Attached hereto and marked as **Exhibit "C"** is a copy of the Streamlined Trial Scheduling Confirmation.
- 10. The Father was served with my affidavit evidence for the Streamlined Trial on January 31, 2025. He then entered into a general security agreement with 1220201 Alberta Ltd. granting an interest of \$1 million. The interest was then registered as a caveat against the land that E.C.P. HOLDINGS (2014) LTD owns. 1220201 Alberta Ltd. is owned by the Father's parents, Rick and Sylvia Bouma, who are the directors and shareholders of the company.

- 11. I believe that the Father and his parents are trying to frustrate my Family Property claim. The most recent Financial Statement my counsel has for E.C.P. HOLDINGS (2014) LTD. is dated February 28, 2022. The amount owing to 1220201 Alberta Ltd. in this Financial Statement is \$442,000.00. The Father has not followed court orders where he was ordered to provide updated financial statements. My expert in the family law matter, Raj Manek, has relied on the loan amount of \$442,000.00 in his expert report based on the financial statements provided by the Father before his counsel withdrew.
- 12. My counsel became aware of the caveat and the GSA when she pulled an updated title search on June 13, 2025. The Father had never disclosed these documents to me.
- 13. On July 18, 2025, my counsel received a copy of the GSA from Duncan & Craig LLP.
- 14. On August 13, 2025, my counsel filed a section 10 notice on an urgent basis pursuant to the *Family Property Act* to add 1220201 Alberta Ltd. as a Defendant so that I can seek remedies to address this new GSA. Attached hereto and marked as **Exhibit "D"** is a copy of my Section 10 Notice filed August 13, 2025.
- 15. On August 22, 2025, Justice Richardson ordered that 1220201 Alberta Ltd. provide all documentation that supports loans advanced by 1220201 Alberta Ltd. to the Father or his companies, including relevant portions of financial statements. She also granted a fiat to call a witness from BDO, who prepares the financial statements for the Father's companies, and I believe for 1220201 Alberta Ltd. as well. Attached hereto and marked as **Exhibit "E"** is a copy of the unfiled order and Notice to Attend, which my counsel advises has been sent for filing and served on BDO.
- 16. I believe the information from the financial statements and the BDO accountant at trial will help to verify how the loan owing from E.C.P. HOLDINGS (2014) LTD (the Father's company) to 1220201 Alberta Ltd. (his parents' company) was being recorded before the Father was served with my affidavit evidence for the Streamlined Trial. I am concerned that

the since being served with my affidavit for the Streamlined Trial that the Father and his parents have taken a number of steps to try to frustrate my interest in the butchery business.

17. I swear this affidavit in response to being served by the Application of 1220201 Alberta LTD. to appoint an interim receiver.

NAME OF THE JUDGE WHO MADE THIS ORDER: Justice L.M. Angotti

UPON APPLICATION by Counsel for the Plaintiff pursuant to Part 8 Division 5 of the *Alberta Rules of Court* at a Rule 4.10 Case Conference;

AND UPON having heard representations by Counsel for the Plaintiff;

AND UPON noting that the Defendant did not attend despite being properly served with notice of the Rule 4.10 Case Conference.

AND UPON HEARING the submissions by or on behalf of the parties;

AND UPON IT APPEARING to the Court that:

- a) the issue or question raised on the claim is suitable for a streamlined trial;
- b) the claim generally is suitable for a streamlined trial;
- c) the streamlined trial will facilitate resolution of the claim or a part of it;

AND UPON IT APPEARING that a procedural order pursuant to Rule 4.11 will assist in managing the action;

IT IS HEREBY ORDERED THAT:

- 1. The hearing in this action shall proceed to a 2 day streamlined trial on a date to be scheduled by the Trial Coordinator no later than September 30, 2025 ("the Streamlined Trial").
- 2. The scheduling of the Streamlined Trial shall follow the following process:
 - a. The Trial Coordinator and the counsel for the Plaintiff shall agree on a range of dates for the Streamlined Trial.
 - b. Counsel for the Plaintiff shall provide the Defendant with the proposed dates. The Defendant shall have 5 business days to agree to one of the proposed dates.
 - c. If the Defendant does not select a date for the Streamlined Trial within 5 business days of receiving the proposed dates, the Trial Coordinator may proceed to book the Streamlined Trial without the Defendant's consent to the date and without the Defendant's signature on the Form 37.

ISSUES

- 3. The issues or questions to be determined at the Streamlined Trial shall be:
 - a) The Divorce Judgment;
 - b) Decision-making and parenting time;
 - c) Retroactive and ongoing child support;
 - d) Retroactive and ongoing spousal support;
 - e) The final division of matrimonial property;
 - f) A Preservation Order; and
 - g) Costs.

TRIAL READINESS

- 4. Any expert reports shall be served 60 days prior to Streamlined Trial. Any reply to the same shall be served 30 days prior to Streamlined Trial. All expert reports and replies shall be in a Form 25 pursuant to Rule 5.34.
- 5. When serving an expert report, either party is at liberty to serve a notice pursuant to Rule 5.39 of their intention to have their expert report entered as evidence at trial without calling the expert as a witness.
- 6. The requirement of the Plaintiff to file a Form 36 is dispensed with.
- 7. The requirement of the parties to engage in a dispute resolution process has been complied with in accordance with Rule 4.16(2).(1).

 parties
- 8. The must attend a second Rule 4.10 Case Conference no later than three months before the scheduled trial date to confirm that the parties have completed the pre-trial requirements contained in the Streamlined Trial Procedural Order and will be ready to proceed to trial. A date for the second Rule 4.10 Case Conference will be provided by the Court Coordinator when the date for the Streamlined Trial is provided.
 - 9. One week prior to attending the second Rule 4.10 Case Conference, the parties must provide a Family Pre-Trial Conference Summary confirming compliance with the Streamlined Trial Procedural Order and readiness for trial.
 - 10. The parties must provide confirmation in writing to the designated Court Coordinator for Family Trials, that the second Rule 4.10 Case Conference has been completed. This confirmation must be provided no later than 7 days after the secured Rule 4.10 Case Conference, failing which the Streamlined Trial date will be cancelled by the Court Coordinator.

EVIDENCE

- 11. Each party shall file one single concise affidavit, based upon that party's personal knowledge and containing all the evidence, including admissible records/documents, which they intend to rely on at the Streamlined Trial. The Affidavits shall be filed and served by January 31, 2025. The Affidavits shall be no longer than 10 pages for the body plus no more than 40 pages for the Exhibits. This shall constitute most of his/her examination in chief.
- 12. Each party shall file a sworn Disclosure Statement with updated disclosure pursuant to items

- 1 through 16 of a Notice to Disclose by February 14, 2025. The attachments to the Disclosure Statement may be relied upon by either party at the Streamlined Trial.
- 13. Each party shall be subject to a one day questioning on their concise Affidavit and sworn Disclosure Statement, which shall be completed by March 31, 2025. Undertakings shall be answered by April 30, 2025. A copy of the transcript of the questioning shall be filed for use as evidence on or before 30 days prior to Streamlined Trial.
- 14. Only the parties and their experts (if their expert is called as a witness) shall be witnesses at the Streamlined Trial.
- 15. Each party is permitted to provide direct testimony for a total maximum of 20 minutes. Each party shall be subject to cross-examination generally, as in a full trial, but the total maximum time for cross-examination of each party shall be 45 minutes. Any rebuttal examination shall be limited to 10 minutes.
- 16. If an expert is called as a witness, each expert witness is permitted to provide direct testimony for a total maximum of 20 minutes. Each expert witness shall be subject to cross-examination generally, as in a full trial, but the total maximum time for cross-examination of each witness shall be 45 minutes. Any rebuttal examination shall be limited to 10 minutes.

ARGUMENT

- 17. Each party shall file a brief limited to 8 pages, including the facts relied on, reasons for the relief requested, and any legal or other arguments. The Briefs shall be exchanged 14 days prior to the Streamlined Trial. Each party shall be entitled to prepare a Reply Brief of no more than 3 pages which shall be exchanged 7 days prior to the Streamlined Trial.
- 18. The parties will each be limited to 45 minutes for closing arguments. Counsel for the Plaintiff will be allowed a maximum 15 minute response to the closing argument of the Defendant.

CONCLUSION

- 19. Subject to rule 7.9, the judicial determination of the issues at the Streamlined Trial shall be a final judgment, not an interim judgment, with respect to those issues.
- 20. If the parties reach agreement on some or all the foregoing issues, the Court shall be immediately advised.
- 21. The parties shall equally share the fee to set this matter for the Streamlined Trial. The Plaintiff shall pay the fee in first instance. The Defendant shall reimburse the Plaintiff half

- of the required fee within 1 week of the Streamlined Trial being scheduled.
- Justice Kiss, Justice Akgungor, and Justice Kendell are disqualified from hearing the matter. 22.
- 23. A copy of this Order shall be provided to the Trial Coordinator's office.
- 24. The Plaintiff is hereby granted leave to serve a copy of this Order and any subsequent documents in this action upon the Defendant by emailing said documents to the Defendant at nbouma20@gmail.com.
- 25. Rule 9.4(2)(c) shall apply.
