Pursuant to an Order of the Court of King's Bench of Alberta on September 26, 2025, G. Chan and Associates Inc. ("Receiver") was appointed Receiver over E.C.P. Holdings (2014) Ltd. ("Holdings") and its subsidiary, Edmonton Custom Packers Ltd. ("Packers") (together "Companies"). The Receiver is undertaking a sale and investment solicitation process ("SISP") and soliciting offers for the assets of the Companies.

The Companies are a third-generation family-owned business operating the only licensed abattoir within the City of Edmonton. Operations have ceased under the receivership. Previously, the Companies were known as Edmonton Custom Packers and offered custom slaughter of livestock, meat processing and packing, in addition to in-house production and retail of traditional European meats and sausages. These services were offered all under one roof. With over 50 years of serving the local community, ECP's customer base included large supermarkets, farmers, and the halal meat sector.

All of the assets of the Companies are being offered for sale in the SISP including a food handling permit, provincial abattoir license, inventory, equipment, and the facility building and lands, which includes an on-site killing floor and indoor/outdoor livestock area.

To facilitate this request for offers, the Receiver will prepare a data room ("**Data Room**") which includes, to the extent available from the Companies' records, a detailed listing of the Property and such other material to assist potential purchasers to conduct such due diligence as those parties may require. Access to the Data Room will only be provided upon the delivery of an executed Non-Disclosure Agreement ("**NDA**"), which may be requested from the Receiver.
