(collectively, the "Applicants"); **AND UPON HAVING READ** the Notice of Application, the Sixth Affidavit of Nigel Woollam sworn January 12th, 2026 (the "Sixth Woollam Affidavit"), and the Confidential Supplement thereto; **AND UPON HEARING** counsel for the Applicants, counsel for G. Chan & Associates Inc., in its capacity as Proposal Trustee (the "Proposal Trustee"), and other interested parties;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

1. Service of notice of this Application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this Application, and time for service of this Application is abridged to that actually given.

B-3, as amended (the “**BIA**”), the period within which the Applicants may file a proposal to their respective creditors is hereby extended to and including February 27, 2026, and the general stay of proceedings against the Applicants is hereby extended to 11:59 p.m. (Mountain Time) on February 27, 2026.
