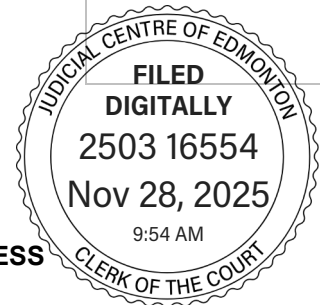

UPON THE APPLICATION by **G. Chan & Associates Inc.** in its capacity as the Court-appointed receiver and manager (the "Receiver") of the undertakings, property and assets of **E.C.P. Holdings (2014) Ltd. and Edmonton Custom Packers Ltd.** (the "Debtors") for an order restricting court access to the Confidential Addendum to the First Report of the Receiver;

AND UPON HAVING READ the Receivership Order dated **September 26, 2025** and filed (the "Receivership Order"), the Orders granted by the Honourable Mr. Justice J.J. Gill on September 26, 2025, the First Report of the Receiver, the Confidential Addendum to the First Report of the Receiver, the Written Submissions of the Receiver, dated November 10, 2025; **AND UPON HEARING** the submissions of counsel for the Receiver, and any other parties present at this Application;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this application and time for service of this application is abridged to that actually given.

RESTRICTED COURT ACCESS

2. The Confidential Addendum to the First Report of the Receiver shall be sealed on the Court file and shall not form part of the public record, notwithstanding Division 4, Part 6 of the Alberta *Rules of Court*, until further Order of this Honourable Court, or the discharge of the Receiver, whichever occurs first.
3. The Clerk of this Honourable Court shall file the Confidential Addendum to the First Report of the Receiver in a sealed envelope attached to a notice that sets out the style of cause in these proceedings and states that:
