TAKE NOTICE THAT:

On June 22, 2026, the above named Company filed a Notice of Intention to Make a Proposal ("NOI") under Section 50.4(1) of the Bankruptcy and Insolvency Act ("BIA"). The Company is restructuring through the NOI proceedings and is not bankrupt.

G. Chan & Associates Inc. has been appointed to act as Licensed Insolvency Trustee (the "Trustee") and acts as an independent Court officer in monitoring the restructuring.

The Company continues to operate in the normal course and existing management remains in control of the business, subject to the Trustee's monitoring. Questions regarding normal course operations can be directed to your usual contact at the Company.

The Company is required to pay post-filing obligations in the normal course. However, upon the filing of a NOI, a stay of proceedings is imposed pursuant to s. 69(1) of the BIA. No creditor has any remedy against the Debtor or the Debtor's property, nor shall any creditor commence or continue any action, execution, or other proceeding for the recovery of a pre-filing claim provable in bankruptcy, except as otherwise provided under the BIA.

The Company is granted an initial period of 30 days to file a proposal and may, before the expiry of the 30-day period, apply to the Court for an extension of up to 45 days. Further extensions may be granted, on application to the Court, to the extent of 45 days for each individual extension, but the aggregate of all extensions cannot exceed 5 months.

No proofs of claim are required from creditors until such time that the Debtor's proposal has been filed, except as may be requested by the Trustee.
