Service

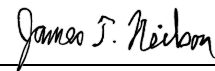
1. Service of the Application and supporting materials is hereby deemed to be good, timely and sufficient.

2. Pursuant to section 50.4(9) of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3 ("**BIA**"), the period within which the Companies may file a proposal shall be and is hereby extended to 11:59 p.m. (Mountain Time) on October 20, 2026.
3. The general stay of proceedings against the Companies imposed by section 69 of the *BIA* is extended to 11:59 p.m. (Mountain Time) on October 20, 2026.
