

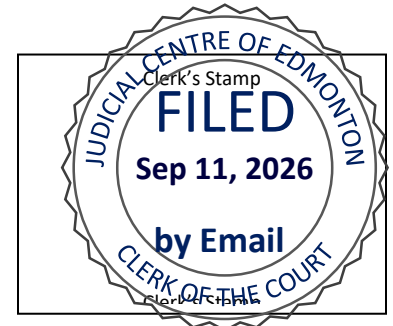

IT IS HEREBY ORDERED AND DECLARED THAT:

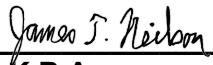
SERVICE

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, and time for service of this application is abridged to that actually given.
2. The Confidential Exhibits to the Second Affidavit of Wade Tyler Eno sworn August 28, 2026 in these Proceedings shall be sealed on the Court file notwithstanding Division 4, Part 6 of the Alberta Rules of Court, Alta Reg 124/2010 until the earlier of:
 - a) a proposal being accepted by the requisite statutory majority of the Companies' creditors that is approved by the Court;
 - b) the sale of the property appraised in the Confidential Exhibits in these proceedings, or any related insolvency proceedings; or
 - c) further order of this Court.(collectively, the "**Unsealing Date**").
