About the Residents' Experience Survey (RES)

What will happen?

In a small group of up to 6 people we will ask you about your experience of the RES interview, the value to you of taking the survey and your ideas on any improvements that could be made to the RES program.

The group discussion will take about 30 minutes to 1 hour.

You don't have to answer any questions and can stop or leave the discussion at any time.

Will other people know what I have said?

The interviewer will write notes as you speak and will not share them with your care provider.

Your information will be kept private and stored in a way that cannot identify you.

A report with de-identified information will be shared with the Department.

Do I have to be involved?

Participation is completely voluntary. It is your choice to participate or not participate.

If you want to participate, but feel uncomfortable speaking in a group, you can have a support person (family or friend) join you. Alternatively, you can chat with us on the phone.

Changing your mind?

There is a potential risk of a privacy breach if personal information is released without authorisation or if other group participants share your views.

Participants must agree to not share personal details of other participants or their views given during the group interview.
