1. Introduction

SDI Kenya is a non-profit organization that exists to shift power so that urban poor communities can plan, negotiate, and drive their own development with dignity. Our work is participatory, incremental, and data-driven, centered on community contributions and leadership. SDI Kenya shares Muungano wa Wanavijiji's vision of creating inclusive cities, where low-income communities have access to adequate housing and services, enabling them to live with dignity.

Shack Dwellers International Kenya (SDI Kenya), in collaboration with Muungano wa Wanavijiji, Nairobi City Water and Sewerage Company (NCWSC) and local community in Kosovo, Mathare, is implementing the construction of a sewer system consisting of lateral lines and simplified sewer systems in Kosovo village, Mathare.

To support the construction of this functional, inclusive and community-led sewer system, SDI Kenya invites qualified and registered suppliers to submit proposals for the supply and delivery of construction materials as per the approved design and Bill of Quantities (BoQ).

2. Scope Of Supply

3. Deliverables

- Timely delivery of all materials to Kosovo project site.

- Delivery notes and invoices for each consignment.
- Warranty/guarantee documents where applicable.

4. Mandatory Requirements

Bidders must submit:

- Certificate of Registration / Incorporation
- Valid Tax Compliance Certificate
- PIN/VAT Certificate
- Detailed company profile
- At least two references for similar supply contracts
- Evidence of capacity to deliver materials in bulk and on schedule
- Proposed delivery timelines

5. Proposal Requirements

Proposals should include:

- Itemized quotation in Kenyan Shillings (KES) aligned to the BoQ.
- Confirmation of ability to meet specifications and timelines.
- Logistics plan for delivery to Kosovo, Mathare.
- Any value additions (e.g., discounted rates, after-sales support, extended warranties).
