### **CEO'S REPORT**

Good afternoon CircusWest members.

Welcome to our 2025 Annual General Meeting. Another year has passed and we find ourselves, like similar not-for-profits, flourishing in some areas and pivoting in others. We are continually grateful for the support from the BC Government, City of Vancouver and the PNE. The past year has brought our focus back to strong governance as we continue to try and stay on course with our strategic objectives. This operational review has intern led to some overdue "housekeeping" changes to our bylaws that have been presented to you with the AGM package. We are also fortunate to add some additional skill sets to the board this past year in both new and old faces returning and a great asset in this governance work. A huge thanks to the entire board for their continued focus on organization and passion for its success. Youth programing remains our core business and bulk of our membership, but we continue to strive outside these classes with the performance pathways required to support them. Over the past year we have been challenged on securing venue space outside our facility and choose to bring our spring community show back in-house here at the Gardens for the first time in several years. This brought more efficiencies along with challenges to the show week, but the cast and crew delivered another amazing Circus for our community. Congratulations to all our cast, staff and volunteers for your tireless work in bringing a season of programming to the stage in this spring performance.

Finally, a huge thank you to our outgoing directors, whose terms have come to an end. Your advisement and support to the organization are appreciated and do not go unnoticed. We continue to solicit new nominations with skills that will align and enrich our governance board, please consider volunteering this year. Appreciation to all our volunteers that make CircusWest such an amazing organization and a privilege to be a part of.

#### TREASURER'S REPORT

First off, I would like to say that I am happy to be back on the Board of CircusWest, working with both the current board members as well as Mark and his incredible team.

This fiscal year saw revenues decrease by 6% over the previous year but was consistent with revenues generated in fiscal 2023. While programming revenue decreased slightly by 2% to \$742,000 over the previous year, it did see a 6% increase over 2023. There was decrease in performance revenue but gains across all other revenue categories combined during the current fiscal year.

Fiscal 2025 saw 83% of organization's revenues being generated mainly from its core businesses (Program and Performance) with this percentage being comparable to 84% and 85% in previous years, respectively.

Expenses slightly increased by 2% compared to fiscal 2023 but decreased by 4% compared to fiscal 2024. There were some non-routine expenses during the year including the creation of a new website which was offset by a decrease in rental expenses as the Spring show moved back into the PNE Gardens. In addition, The organization continues to run a deficit which has been consistent over the past few years. Operating reliance decreased slightly from 83% in 2023 to 82% in 2024 to a comparable 80% in 2025 (which means the revenues from its core lines of business covered 80% of the organization's costs in 2025 as opposed to 82% the prior year and 83% in 2023). The reason for the continued strong operating reliance was due to management continuing to be fiscally prudent in delivering on its core business.

These deficits have drawn down on prior years General Fund balance to end at \$55,904. There is also \$28,185 in a Capital Asset Reserve Fund for total healthy ending Fund balance of \$84,089.

As of August 31, 2025, the organization had approximately \$247,000 in cash, a decrease of 6% over the prior year. Current as sets of \$252,000 are in excess of the current liabilities \$222,000 demonstrating the organization's ability to meet its current obligations.

Going forward, CircusWest will continue to improve its operating reliance with increased revenues from its core businesses while continuing to be fiscally prudent.

Thank you to management, staff, volunteers, donors and granting bodies for your dedication and continued support.
