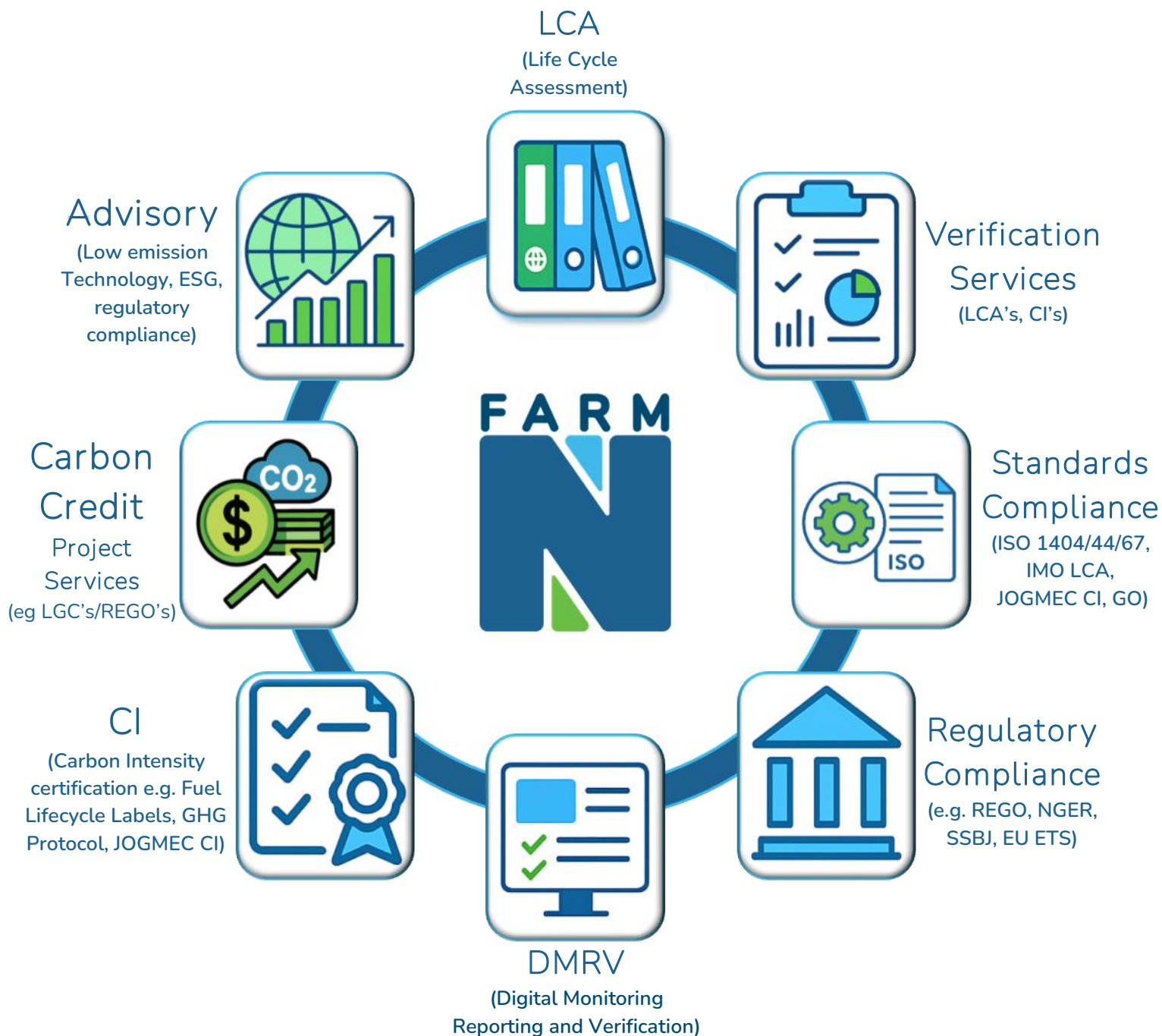

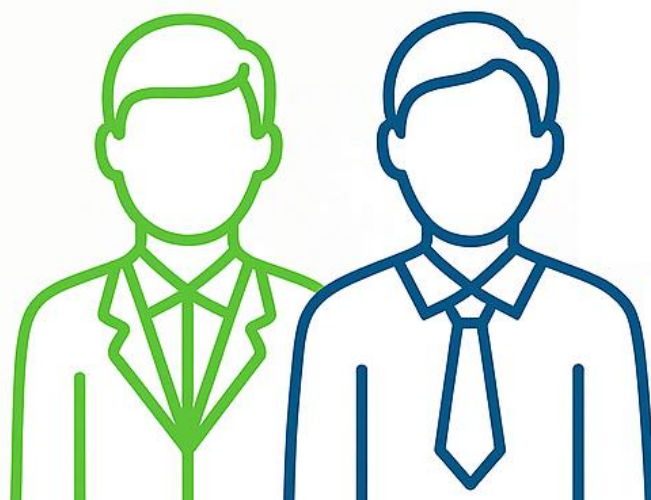

LCA's

Through FarmN's LCA service, you will obtain a quantified, third-party-verifiable CO₂e footprint for your products and operations. This underpins all subsequent certification and credit efforts.

It demonstrates to regulators, investors, and partners the emissions performance of your low emission products, building credibility. It also provides a data foundation for pursuing product Carbon Intensity certifications, Carbon Credits and for substantiating any "green" claims in the marketplace

Carbon Intensity Certification

You will receive verified CI documentation for your products, enabling you to confidently claim and label them as "green hydrogen – X kg CO₂e/kg" or "green ammonia – Y% lower emissions than conventional", etc. These certificates will support compliance with both industry (e.g. IMO) and regulatory programs (e.g. Australia's GO scheme and the EU and UK's CBAM) and bolster your ability to secure green premium contracts. In essence, CI certification translates the LCA analysis into a market-facing credential that can unlock both reputational and financial value.

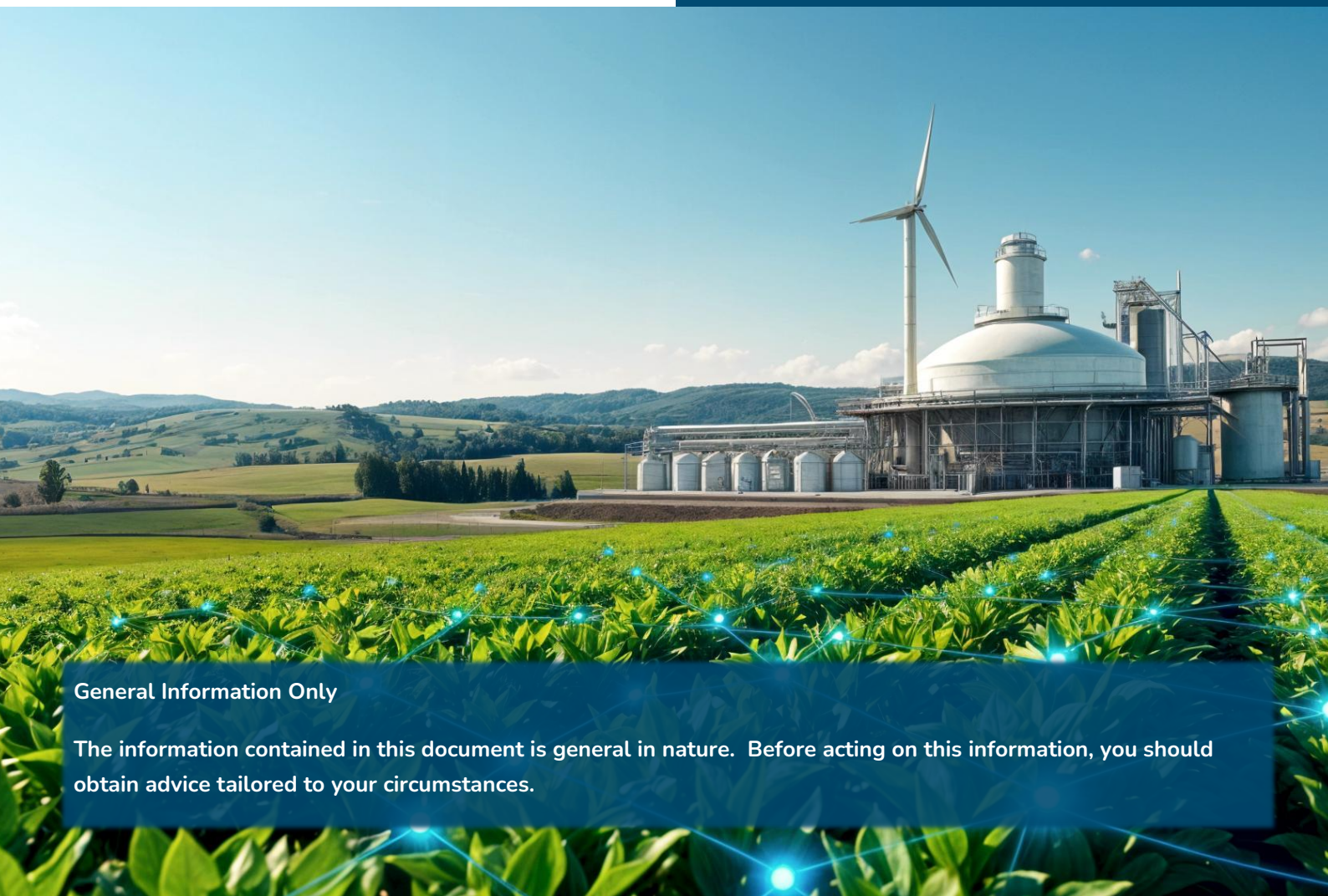
