### Agreement Terms:

1. Goods for Consignment 1.1. The Consignor agrees to provide the items listed in the attached Inventory List (Exhibit A), including descriptions and quantities. 1.2. Corner Luxe Consignment will have sole authority to determine the retail prices for the items based on factors such as market demand, condition, and quality. 1.3. Corner Luxe Consignment reserves the right to put items on sale or offer discounts after a reasonable period of time to encourage sales. 1.4. Corner Luxe Consignment will display, market, and sell the items in-store and/or online. 1.5. Any unsold items will be returned to the Consignor after 60 days unless otherwise agreed in writing.

2. Ownership and Authenticity. 2.1. The Consignor warrants that they are the rightful owner of all goods provided and that the items are authentic, free of counterfeit materials, and not subject to any liens or disputes. 2.2. The Consignor agrees to provide documentation, such as receipts or certificates of authenticity, upon request. 2.3. Corner Luxe Consignment reserves the right to inspect and verify the authenticity of the goods. Items deemed inauthentic or otherwise unsuitable will be returned to the Consignor.

3. Commission and Payment. 3.1. For each sale, Corner Luxe Consignment will retain a commission of \_\_\_\_% of the sale price, with the remainder paid to the Consignor. 3.2. Payments will be made when the Consignor visits the store to collect proceeds.

4. Handling and Liability. 4.1. Corner Luxe Consignment will handle the goods with reasonable care and store them securely but is not liable for loss, theft, or damage unless caused by negligence. 4.2. The Consignor is responsible for ensuring high-value items if desired.

5. Entire Agreement. 5.1. This Agreement constitutes the full understanding between the parties and supersedes all prior agreements. 5.2. Any amendments must be in writing and signed by both parties.
