- The Celtic Club has less than 600 members. The 2021 Census states Victoria has approximately 625,000 people with Irish heritage. What has the Board done to embrace and support our Irish community and therefore expand our membership? Our Club is not sustainable and not truly representative of our Irish community with so few members.
- 2. The Board rewrote much of our Rules. Rule 80 has now been removed. It stated the Board was not permitted to exchange or sell property without the sanction of 75% of members at a General Meeting. The Board can now sell our property without our consent. Why did the Board remove this requirement?
- 3. Our membership fees have been increased dramatically without consultation with members. To maintain our membership, we have been forced to have a "tab" and provide our credit card details. Any unspent money will be taken by the Club at the end of the year and we have to pay anew the following year. If your "tab" falls under \$30 money will be automatically deducted from your credit card. We did not agree to this.

Heritage, Audit and Membership Committees have been abandoned. I will re-establish them Immediately.


My Commitment
