Within few mimute they set on fire all the three doors of our houses I alongwith my younger brothers Kuldip Singh and Gurait Singh and two other sikhs who had also entered our boose at that time for shalter were defending ourselves from the key of the house which was a double storey house. We had shifted females of our family alengwith my father Swarcop Single and relatives Abrik Singh and Tarlockan Singh and children in the house of our neighbourer known as Patwari on the back side,

4. That we went on defending ourselves tirelessly and were seeing from the top of our house that DIC buses of Buses of Bargana Readways, were bringing and boarding down non-sikbs in hundreds who were armed with Lathies. In about one hours time, the mob swelled into about 2000 persons. We received number of injuries.

5. At thatties about 10 Pelies Officials were also present at the spot and they were encouraging the mob to fill us. I saw Sajjan Kumar, the then Congress (I) M.P of our area standing exongst the mob and he was directing the mob to attach us with more and more force and kill us.

among that nob I could identify several persons of the locality. Some of them are one Prem Chand Jain r/o I -149 Mangalei J.J.Colony No. 1, Delhi, a son of Bilk Vendur of the same locality i.e. ?? That we all the three brothers were having swords in ourhands. But the other two sikhs who took shelter in our house were not baving any arms with them. There were two other sikh neighbourers abso who were armless. All these four sikhs were killed by the aforesaid persons and mob within four hours. At about 2 PM or 2.30 PM Railway Train from Robitak Side came and stoped near the Gurdwara in our colony. About 2000 non-sikh; alighted from therain, some of them were carrying lathies, while the oth resome were carrying iron rods and seet of them were carrying keresine oil cont inorse. All of them attached us fith fall force. My father S.
