Police Blast Public Over Release of Graphic Crime Scene Photos From Gypsy Rose's Case Gypsy Rose served seven years in prison for convincing her boyfriend to kill her mother and has sparked a new interest in her case since her release. The crime scene photos have now gone viral, but the sheriff's office claims they were not leaked and that police track every time records are released. A podcaster named April Johns recently claimed she uploaded the files, saying they belonged to her and had been public for nine years. Gypsy Rose and her husband had been expecting their first child together, but rumors about a possible separation seemed to be ignored. However, after several hints from Gypsy Rose herself, the couple confirmed they would be parting ways in March. Following their separation, Gypsy Rose was spotted getting matching tattoos with her ex-fiance Ken Urker, although neither of them acknowledged whether they were a couple or not. In July 2024, Gypsy Rose announced she was expecting her first child with Ken. Recent crime scene photos leaked online showed the home where Gypsy and her mother Claudine 'Dee Dee' Blanchard lived for several years. The images revealed a cluttered and disorganized environment, as well as evidence markers scattered throughout the house. The photos also depicted pill bottles and family belongings spread out on countertops. Furthermore, they showed detailed images of Dee Dee's deceased body after being stabbed 17 times in the back. Gypsy Rose, who was released from prison almost eight months ago, has been making headlines with her new endeavors. Since her release, she has filed for divorce from her husband and rekindled an old romance. In July, Gypsy announced that she is expecting a child with Ken Urker. April Johns, former spokesperson for Gypsy Rose Blanchard, explained how the crime scene photos of Dee Dee Blanchard's bedroom went viral on TikTok. She said that the link to the drive is her files and that the crime scene photos have been publicly available since nine years ago through a Freedom of Information Act request. Johns emphasized that many people could have obtained the documents if they wanted, but only recently started sharing them, suggesting that people were either newly aware of the case or had chosen to be ignorant about it until now. April Johns claimed she had gotten those photos a long time ago and wasn't responsible for sharing them on Gypsy's birthday, saying they'd been all over Facebook and Reddit for years. She mentioned that the photos were part of their media partnership, which fell apart. The Blanchard family - consisting of Gypsy, her father Rod, stepmother Kristy, and stepsister Mia - had a lawsuit against Johns, accusing her of defamation, fraud, breach of contract, unjust enrichment, and false light. They stated that they worked with Johns for over two years but didn't receive any marketable content from her. The family eventually severed ties in 2019 due to her confrontational behavior towards Gypsy's relationship with Ken. After the split, things escalated as Johns referred to Gypsy as a "dangerous frickin person" and used derogatory language on YouTube. She was also accused of creating and profiting from content that targeted the Blanchard family despite having multiple social media accounts suspended. Gypsy Rose since her case against a blogger was dismissed by a court has made no further attempts to sue. However, she is more positive about her life now that she is expecting her first child with fiancé Ken Urker. She recently announced on Instagram that they are having a baby in January 2025 and shared photos of herself and Urker posing for the cameras. Gypsy Rose's past has resurfaced due to recent interest in her case. Her ex-husband, Ryan Anderson, weighed in on the leaked crime scene photos, saying "She did her time" Her mother's death drew attention recently after Gypsy Rose announced she is pregnant. Despite this, social media platforms have been flooded with crime scene photos and discussions about the murder of her mother, Dee Dee Blanchard. The public's curiosity about death and violent crimes like Blanchard's is natural, but there is a time and place for everything, and that place is rarely on someone's birthday.
