
The potential impact of Generative AI can be evaluated through two lenses.



- Warranty Cost (Financed): \$849 (including interest over 36 months at 3.9%)
- Coverage Duration: 5 years
- Probability of Filing a Claim Over 5 Years: 10% (0.10)
- Average Repair/Replacement Cost per Claim: \$1,277 (combined average for tire and wheel incidents)

Expected Payout Calculation: Expected Payout = (Probability of Claim) × (Average Repair/Replacement Cost) Expected Payout = $0.10 \times \$1,277 = \127.70 **Net Expected Value:** Net Expected Value = Expected Payout – Warranty Cost Net Expected Value = \$127.70 - \$849 = -\$721.30


Interpretation

With the revised 10% probability of filing a claim, the expected payout over five years is approximately **\$127.70**. When compared to the financed warranty cost of **\$849**, this results in a **net expected loss** of **\$721.30**.



The difference between a good prompter and a great prompter is not 10%. It's 10x.


