The Applicant understands and agrees that this application and acceptance of same by the Company is contingent upon: (i) the applicant receiving all regulatory approvals, if any, needed to become a member of the Company; (ii) the Applicant being found acceptable for insurance by the Company; (iii) the Company's quotation of an insurance premium and offering of insuring terms to the Applicant and the Applicant's acceptance thereof; and (iv) the payment by the Applicant of all requisite premiums to the Company.
