Europe's Competitiveness at a Crossroads: a stocktaking one year after the Letta and Draghi Reports

In the current geopolitical and economic context, **strengthening Europe's competitiveness** is a necessity. Global fragmentation, trade barriers, technological disruption, and the green transition are reshaping value chains and investment flows. In this context, the European Union must act decisively to ensure that its policy frameworks foster innovation, investment, productivity, and industrial resilience.

Building on **TEHA's Position Paper**, which examines the current state of European competitiveness, this high-level event will bring together prominent figures from the policy and industrial spheres, alongside academics and thought leaders, to reflect on the **progress** and **gaps** in **Europe's competitiveness, one year after** the publication of the **Letta** and **Draghi Report**.

Following the **keynote** by **Enrico Letta** (Dean, IE School of Politics, Economics & Global Affairs; Rapporteur on the Future of the EU Single Market), and the **presentation of the Position Paper** by **Lorenzo Tavazzi** (Senior Partner and Board Member, TEHA Group) the event will feature **two panel discussions**. The first will explore the different dimensions of competitiveness - where the EU must increase its capacity to act - while the second will focus on sustainability reporting and simplification. Each panel will include a Q&A session to foster open debate.
