This letter is submitted on behalf of Intrado Communications, LLC (“Company”) to notify the Arkansas Public Service Commission (“Commission”) that the Company is changing its corporate name to Hypercube Networks, LLC. In Arkansas, the Company was originally authorized to provide resold and facilities-based local exchange and resold interexchange services pursuant to the authority granted in Docket 01-150-U, Order 2.

Enclosed as Exhibit A is a copy of documentation on the registration of Hypercube Networks, LLC with the Arkansas Secretary of State.

The notice of change in Company name that was provided to Arkansas customers is included as Exhibit B. The change in corporate name will have no effect on the rates, terms, or conditions of service offered to customers.


