## Sir Adrian Solomons Law Bursary



Each year, Everingham Solomons offers a Tamworth, Gunnedah, Manilla or Quirindi Year 12 student wishing to undertake university study in law the opportunity to receive a Bursary funded by this firm. For the 2024 Bursary, Everingham Solomons has extended the law Bursary to current university students studying law.

The Sir Adrian Solomons Memorial Law Bursary was first granted in 1998. It provides financial assistance for the successful applicant during their time at university as well as an opportunity to gain valuable work experience in our offices periodically throughout the duration of their studies.

Each year, the Principals or Career Advisors of local High Schools and the Scholarship Departments at universities are contacted and advised of the details. Interested students can then liaise with the Principal or Careers Advisor of their school, or Scholarship Departments from their respective university who will assist them in making a formal application for this Bursary. Alternatively, students can also contact our office to obtain information in relation to the Bursary.

We appreciate that students come from a variety of backgrounds and accordingly the selection process concentrates on the attributes of the student as a whole, rather than merely academic achievement.

Applicants should present as a diligent, well rounded and personable and should demonstrate a strong commitment to their local community and region.

Whilst the intention is to award the Bursary each year, in absence of a suitable Applicant, the Bursary may not be awarded.

### **About Sir Adrian Solomons**

Sir Adrian Solomons completed his secondary education at Tamworth High School before commencing university studies in law in 1940 at the University of New England and later at Sydney University.

Sir Adrian returned to Tamworth after his admission as a legal practitioner in 1949 to become a respected solicitor and founding partner of Everingham Solomons.

After twenty successful years of legal practice, Sir Adrian took on the challenge of the political arena, entering the NSW Legislative Council in 1969 for the National Party. Despite the pressures of parliament, Sir Adrian remained a consultant to the firm until 1989.

Sir Adrian was knighted by Her Majesty Queen Elizabeth II at Buckingham Palace in 1982 for services to law and government.

Sir Adrian resigned from public office in 1991, having made a significant contribution to Tamworth & district in both the political and legal fields.

Sir Adrian Solomons passed away in 1991.
