- The content does not place yourself or others at risk of harm

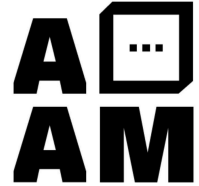
Beyond DV encourages respectful, survivor-centred, and non-triggering contributions. Content promoting violence, abuse, or unsafe behaviours will not be permitted.
