- Reduced manual workloads, reduced risk



Real-time monitoring of data flows, writes, edits and anomalies.

Feedback loops, model tuning, evolving rules & posture.






INTELLIGENT FEATURES

 cause or risk drivers.
- Policy Enforcement & Compliance Engine

Automatically enforces integrity rules namely immutability, audit logging, and field protection by detecting, flagging, and rejecting any violations in real time.

- ➤ Alerting & Escalation Workflows Configurable thresholds, multi-level notifications, routing to responsible teams when breach or drift occurs.
