What is this product?

Type
This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to actively manage convertible bonds, bonds exchangeable into international securities, equivalent securities, and equity op-

This sub-fund invests at least 50% in convertible bonds.

In addition, it may also invest in other types of bonds, transferable securities, money market instruments and units of undertakings for collective investment (up to a limit of 10%), without restriction in terms of the economic sector or geographical origin.

Up to 80% of the sub-fund's exposure to equity markets may be achieved by direct holding of equities (up to 20% of net assets), through investments in convertible bonds, exchangeable bonds and equivalent securities.

The sub-fund will not invest in contingent convertible bonds (CoCos).

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is intended for investors seeking income and capital preservation

over a medium to long time horizon (at least 4 years). The investor may incur losses up to the amount invested. This product is suitable for investors with basic to in-depth knowledge and experience of the product and global bond markets.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

Risk indicator

What happens if BELLATRIX ASSET MANAGEMENT S.A. is unable to pay out?

To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 4 years
