# **Project Details**

# Objective(s):

- 1. Determine the date of death of Samuel Rogove.
- 2. Determine if an estate was ever raised for Samuel Rogove.
- 3. Build a family tree identifying all living relatives of Samuel Rogove, who was involved in a lawsuit in the 1940s, focusing first on children, with a secondary focus on parents, siblings and nieces/nephews of Samuel Rogove, if children are not identified.

# Background Information:

# **Background Personal Details**

The birth date and location of Samuel Rogove, as well as the names of his parents, are currently unknown. Similarly, the date and location of his death remain unidentified. Although Samuel owned real estate in Philadelphia, Pennsylvania, it is unclear if he resided or died there. The client has speculated that Philadelphia was his place of residence and possibly his place of death, but this has not been confirmed. A search of the Register of Wills of Philadelphia revealed that no estate had been opened for Samuel Rogove.

It is also unknown whether Samuel Rogove was ever married.

#### **Search Results**

The client has provided search results from Ancestry.com related to Samuel Rogove. However, they believe these records may pertain to more than one individual with the same name in Philadelphia. It is uncertain which, if any, of these results correspond to the correct Samuel Rogove.

## **Real Estate Ownership**

Samuel Rogove owned two properties in Philadelphia:

- 1. **942 N. 2nd Street** 
  - o Acquired by deed dated May 18, 1921.
  - o This property was later sold at a sheriff's sale following a lawsuit: *Trustees of Green Street Monthly Meeting of Friends of Philadelphia, a Corporation v. Samuel Rogove* (Court of Common Pleas of Philadelphia, December Term 1940, Number 1930).



The client has provided the deed for this property as well as the sheriff's deed. The sheriff's deed contains additional details about the lawsuit.

2. Adjacent Flag-Shaped ParcelAcquired by deed dated January 5, 1925.






#### **Research Details**

A diligent search and inquiry has been conducted into identifying the Samuel Rogove who owned the Philadelphia property known as 942 North Second Street, details as to whether a probate was raised for the estate of said Samuel Rogove and the whereabouts of the living descendants of Samuel Rogove, the report of which follows:

Generation 1: Subject, Samuel B. Rogove



That no Russian birth certificate was obtained for Samuel B. Rogove, and though he inconsistently reported his age and birthdate in United States records, he is believed to have been born on or about 15 January 1889 in Kiev, Russia, possibly in [a small historic village called] Beletsarkov; (exhibits 2, 3, 6a, 7, 8, 9 and 10),<sup>1</sup>

That Samuel Rogove immigrated to the United States on 4 July 1901, arriving in the Port of Philadelphia aboard the vessel *SS Peimland* (exhibit 10),<sup>2</sup>

That based on information extracted from the Philadelphia County, Pennsylvania Marriage License Index, Samuel Rogof [Rogove] and Lena Epstein were issued a marriage license in 1909 at Philadelphia County, Pennsylvania (exhibits 68 and 69)<sup>3</sup>,

That Samuel and Lena Rogove were enumerated as husband and wife, as of 15 April 1910 (exhibit 9),4

That Samuel Rogove submitted his Declaration of Intention to become a citizen of the United States in the Circuit Court of the Eastern District of Pennsylvania at Philadelphia on 6 September 1911 and became a naturalized citizen on 16 February 1914 (exhibit 10),<sup>5</sup>

That based on details extracted from a vital, citizenship and military records, Samuel Rogove and Leah Epstein Rogove were the parents of three children who survived to the age of majority:

- 1. Isiah S. Rogove [later known as Irving], born on 28 March 1910 (exhibit 11),6
- 2. Edna Rogove, born 17 January 1913 (exhibit 10),7

# 3. Herbert J. Rogove, born 11 May 1924 (exhibits 55a, 55b, 60a and 60b),8

That based on information compiled from various records that Samuel B. Rogove worked within the food industry while residing in the United States and was occupied as a fishmonger in 1910, a fish dealer in 1914, a retail meat dealer in 1920, as well as a meat store butcher in 1930 and 1940 (exhibits 6a, 6b, 7, 8, 9 and 10),9

That based on information extracted from two obituaries, Samuel B. Rogove died on or about 9 November 1954 in Philadelphia County, Pennsylvania (exhibits 4a and 12a),<sup>10</sup>

That based on the response letter provided by the Philadelphia County Register of Wills Office, a search was conducted from 9 November 1954 through the present day and no record could be located regarding an estate being probated for Samuel Rogove in Philadelphia County, Pennsylvania (exhibit 61),<sup>11</sup>

That the wife of Samuel B. Rogove, Lena Rogove née Epstein, died on 10 June 1983, with two adult children, Irving and Edna, surviving (exhibit 12a),12

# 942 North Second Street, Philadelphia, Pennsylvania

That while no direct evidence proved ownership by Samuel Rogove of the property known as 942 North Second Street, Philadelphia, Pennsylvania, indirect evidence supports that Samuel Rogove was affiliated with this property,

That based on information extracted from the 1891 and 1903 Philadelphia City Directory listings, Julius Spicker resided at 942 North Second Street (exhibits 50a and 50b),<sup>13</sup>

That Julius Spicker entered into an indenture to convey a land deed to Fannie Petrovsky on 30 April 1907 (exhibit 65),<sup>14</sup>

That the indenture between Julius Spicker (grantor) and Fannie Petrovsky, wife of Abraham Petrovsky (grantee), was for a property the boundaries of which were described as "...Beginning at the Southwest corner of Second and Canal Streets in the sixteenth ward of the City of Philadelphia thence extending southward along the West Side of the said Second Street seventeen feet eight and one half inches to a point thence westward of right angles with said Second Street and through the middle of a nine inch wall fifty-three feet six inches thence north forty degrees, twenty-three and one-half minutes west sixteen feet two and one-half inches to a point thence north nineteen degrees forty-nine minutes East, seventeen feet three inches to the south side of said Canal Street and thence eastward along the south side of said Canal street, sixty four feet three and one-half inches to the just mentioned point and place of beginning bounded northward by said Canal Street southward partly by ground and as late of Joseph de Silver and partly by ground now or late of the Northern Liberties Gas Company westward by ground now or late of the said the Northern Liberties Gas Company and eastward by Second Street aforesaid" (exhibit 65), 15

That based on the 1908 Philadelphia City Directory, Julius Spicker resided at 2003 North Thirty-First Street (exhibit 50c), 16

That based on the same 1908 Philadelphia City Directory, as well as a 1909 published notification, Frank Petrovsky [also Petroskey] resided at 942 North Second Street (exhibits 35a, and 50d),<sup>17</sup>

That based on a report from the Mayor of Philadelphia in 1910, Fannie Patrosky [Petrovsky] resided at 942 North Second Street (exhibit 38),18

That based on information extracted from the 1921 Philadelphia City Directory, Abraham Petrosky resided at 942 North Second Street (exhibit 40),<sup>19</sup>

That Abram Frank Petrovsky *et ux* entered into an indenture to convey a deed to Samuel Rogove on 18 May 1921 (exhibit 66),<sup>20</sup>

That the indenture between Abram Frank Petrovsky and Fannie Petrovsky his wife (the grantors) and Samuel Rogove (grantee) all of the City of Philadelphia was for a property with the buildings and improvements described according to a "survey made thereof by Andrew French Surveyor and Regulator of the Fifth District on the fourteenth day of May A.D. 1875," and the boundaries of which were described as "Beginning at the Southwest corner of Second and Laurel (formerly Canal) Streets in the sixteenth ward of the City of Philadelphia thence extending southward along the West Side of the said Second Street seventeen feet eight and one half inches to a point thence westward of right angles with said Second Street and through the middle of a nine inch wall fifty-three feet six inches thence north forty degrees, twenty-three and one-half minutes west sixteen feet two and one-half inches to a point thence north nineteen degrees forty-nine minutes East, seventeen feet three inches to the south side of said Laurel Street and thence eastward along the south side of said Laurel street, sixty four feet three and one-half inches to the just mentioned point and place of beginning bounded northward by said Laurel Street southward partly by ground and as late of the Northern Liberties Gas Company Westward by ground now or late of the said The Northern Liberties Gas Company and eastward by Second Street aforesaid" (exhibit 66),21

That this property was described in the deed as "...being the same premises which Julius Spicker Widower by Indenture bearing date Thirtieth day of April 1907 and recorded at Philadelphia in Deed Book W.S.V. No. 578, page 25 &c granted and conveyed unto the said Fannie Petrovsky wife of Abram Frank Petrovsky in fee" (exhibit 66),<sup>22</sup>

That this property was likely the same 942 North Second Street where the Petrovskys were listed as residents in 1908, 1910 and 1921 (exhibits 35a, 38, 40 and 50d),<sup>23</sup>

That based on details extracted from the 1930 Census and a published notice newspaper, the 942 North Second Street was provided as the address for a "Male Help Wanted" advertisement placed in June 1924 for a meat cutter, which corresponded with the occupation of Samuel Rogove as a butcher (exhibits 7 and 28),<sup>24</sup>

That based on research conducted, all reasonable efforts to locate any further information on this address have been exhausted,



That based on details extracted from marriage license (and return) no. 691767, issued on 13 June 1938 by the City of Philadelphia, Irving Rogove married Adele Flashner on 19 June 1938 (exhibits 67a and 67b),<sup>26</sup>

That based on details compiled from obituaries, two known children were born to that union (exhibits 17 and 18),<sup>27</sup>




- 1. Herbert Rogove, born 8 May 1947,<sup>28</sup>
- 2. Lynn Rogove, born 21 July 1951,<sup>29</sup>

That based on information provided in the Social Security Applications and Claims Index and an obituary, Irving Rogove died on 21 January 2000; that his survivors were two children, Herbert Rogove and Lynn Spector [née Rogove], as well as four grandchildren: Jordan, Gregory, Adam and Andrew (exhibit 017),<sup>30</sup>

That based on information provided in the obituary of Adele Rogove, the widow of Herbert, she died on 1 April 12009; that survivors were two children, Herbert Rogove and Lynn Spector, and three grandchildren: Jordan Rogove, Gregory Rogove, Andrew Spector; that grandson Adam had preceded her in death (exhibit 18),<sup>31</sup>
