

## Gun Industry Lobbying Q2 (April—June) 2025

In July 2025, Guns Down America examined Lobbying Disclosure Act records submitted by representatives of major firearms companies and trade associations.

Lobbyists for the firearms industry had another busy quarter pushing their agenda in Congress, at the White House and across the federal government.

The National Shooting Sports Foundation (NSSF) continued its reign as the biggest player in the space with over \$1.78 million spent to push its pro-gun business agenda. NSSF spent more than twice as much as Gun Owners of America (\$679,015) and more than three times as much as the National Rifle Association of America (\$480,000) and nearly six-times more than the National Association for Gun Rights (\$304,783).

## **Notable Findings**

## **Gun Industry Put Dollars Behind Trump's Giant Bill**

A key priority across the industry last quarter was President Trump's wide-ranging tax and budget legislation, the so-called One Big Beautiful Bill Act, H.R. 1. Specific references to H.R. 1 and/or the budget resolution were included in Lobbying Disclosure Act filings from Naamo Inc., Silencer Central, the American Firearms Association, American Suppressor Association, Firearms Regulatory Accountability Coalition, Gun Owners of America, NRA and NSSF.

The final bill, which Trump signed in early July, included language that will eliminate a \$200 National Firearms Act (NFA) tax stamp fee on suppressors and short-barrel rifles, a priority for the industry. However, it did not go as far as some would have preferred. For example, the American Firearms Association said its support for H.R. 1 would come only "with fully adding in NFA deregulation, not just the \$200 tax repeal."

#### **Notable Names**

It's hardly unusual for Washington lobbyists to trade on connections they've made over the course of their personal and professional careers. Still, a few notable names caught our eye in this quarter's batch of filings:

- <u>Daniel Diaz-Balart</u>, nephew of Rep. Mario Diaz-Balart (R-Fla.), represented Centre Firearms Co. on behalf of TSG Advocates DC, LLC.
- Former NRA Executive Director <u>Chris Cox</u>, now a lobbyist with Capitol 6 Advisors, added Sig Sauer as a client this quarter.
- <u>Christopher LaCivita Jr.</u>, the son of Trump's 2024 campaign manager, added NSSF as a client this quarter on behalf of Checkmate Government Relations.




