Gun Industry Lobbying Q4 (October–December) 2025

In January 2026, Guns Down America examined Lobbying Disclosure Act records submitted by representatives of major firearms companies and trade associations in the fourth quarter of 2025.

The gun lobby pushed for legislation that would require the government to process firearms applications during government shut downs, claiming it was an essential service, even while life saving services like the Supplemental Nutrition Assistance Program (SNAP) benefits lapsed and hunger increased.

Lobbyists are also raising rates as gun groups raise the stakes—with significant investments made in judicial nominations.

Notable Findings

Shutdown Can't Slow Down the Gun Business

The major gun groups spent part of last fall working to make sure that the [longest government shutdown in history](#) wouldn't hinder the firearms trade.

Supporting the Firearm Access During Shutdowns Act of 2025 was among the new priorities disclosed on the most recent lobbying disclosures. The National Rifle Association, National Shooting Sports Foundation and National Association for Gun Rights all listed support for the bill (S. 3085/H.R.5874) among their priorities in the final quarter of last year.

The legislation, sponsored by Rep. Ben Cline (R-Va.) and Sen. James Risch (R-Idaho), [would have required](#) the federal government to keep processing firearms applications and licenses even when Congress fails to pass an appropriations bill on time.

NSSF praised the lawmakers for their "leadership" in sponsoring the legislation. "The Firearm Access During Shutdowns Act would in essence deem these agency functions as 'essential,' requiring the pertinent federal agencies to continue processing firearm applications and licenses during a lapse in appropriations," [NSSF's Larry Keane wrote](#). "If the federal government is going to maintain gatekeeping authority over firearm transfers, NFA items, import permits and licensing, it must keep those gates open for law-abiding citizens regardless of the political calendar."

The legislation did not see action before Congress re-opened the government in mid-November with a stopgap spending bill that expires at the end of January.

Gun Groups Aim to Buy Judges

In addition to its legislative priorities, NSSF lobbyists also spent their time on nominations fights last quarter, according to its latest filing.

NSSF listed three nominations: Eric Chunyee Tung for the United States Court of Appeals for the Ninth Circuit; ATF Director-nominee Robert Cekada; and Travis Hill, Trump's pick to chair the Federal Deposit Insurance Corporation.

Tung was [confirmed in November](#) on a 52-45 vote to join the 9th Circuit, the retiring Judge Sandra Ikuta, a George W. Bush appointee who [wrote the opinion](#) overturning California's effort to require background checks for purchases of ammunition.

The Los Angeles Times described Tung as an "[arch-conservative](#)" with pro-gun views, and he is a longtime competitive target shooter and [member](#) of the International Defensive Pistol Association.

Related, the National Association for Gun Rights also lobbied for a bill that would allow judges and prosecutors to concealed carry on the job.

Lobbyists Are Raising Rates

Checkmate Government Affairs appears to be raising its rates – or maybe just collecting some year-end bonuses.

Lobbying fees nearly doubled for the four gun companies represented by Checkmate, Beretta USA Corp.; Glock, Inc.; Springfield Armory; and Taurus Holdings, Inc.

All four companies went from paying \$50,000 in the third quarter to \$90,000 in the fourth quarter.

Better Late Than Never

Gun Owners of America has now been submitting their lobbying disclosures late for the past two quarters. This report details their Q3 spending which includes policies not only about guns, but democracy:

- A bill that would establish a federal sales tax and abolish the IRS
- A bill that would make it easier to restore gun rights for previously convicted criminals
- A bill that would implement restrictions around voting
- A bill that would prohibit a state or local government from establishing firearm laws that are more restrictive (or that imposes a greater penalty or tax) than federal law.

- **Beretta USA Corp.** paid \$90,000 to Checkmate Government Relations to lobby the Trump administration on issues related to trade and the rights guaranteed by the Second Amendment.

- **Silencer Central** paid \$50,000 to Natural Resource Results LLC (which paid \$20,000 to the Bernhardt Group) to lobby Congress and the executive branch on issues related to tax stamps on suppressor sales, regulations on suppressors, and legislation to promote suppressor use.
- **Smith & Wesson Brands, Inc.** paid \$30,000 to Mike Williams Capitol Strategies LLC and \$60,000 to Steptoe LLP to lobby Congress and the Trump administration on issues related to the manufacture, distribution and sale of firearms; financial institutions “discrimination” against firearms manufacturers; and policies related to the Arms Export Control Act.
- **Springfield Armory, Inc.** paid \$90,000 to Checkmate Government Relations to lobby the Trump administration on issues related to trade and the rights guaranteed by the Second Amendment.

- **Silencer Shop** paid \$45,000 to Shumaker Advisors, LLC, which did not report any lobbying activity for the quarter.
- **Unit Solutions, Inc.** paid \$50,000 to Brownstein Hyatt Farber Schreck, LLP to lobby Congress on issues related to tactical firearms training.

Trade Associations

- **The American Suppressor Association** paid \$40,000 to Tholos Government Relations to lobby Congress and the executive branch on issues related to H.R. 1, the “One Big Beautiful Bill Act” and Forms Processing.

- **Gun Owners of America** spent \$465,065 in the third quarter to lobby Congress and the executive branch on an array of firearms policies, but it had not filed its fourth-quarter report by the Jan. 20 deadline.
- **The National Association for Gun Rights** spent \$136,298 to lobby Congress and the executive branch on a variety of firearms-related legislation and policy.
- **The National Rifle Association of America** spent \$450,000 to lobby Congress and the executive branch on issues related to firearms policy.
- **The National Shooting Sports Foundation** spent \$1.56 million, including hiring five outside firms, to lobby Congress and the executive branch on various firearms legislation and regulations.
- **Walk the Talk America** paid \$10,000 to Da Vinci Group to lobby Congress on issues related to firearm safety.
