
All such companies are requested to contact Bangladesh Investment Development Authority (BIDA) to complete the necessary formalities and regularize their status on or before **22 June 2026**.

Furthermore, all BIDA-registered companies and employers engaging foreign nationals are strongly advised to ensure that their foreign employees and investors possess valid work visas and work permits at all times.

This notice is issued for strict compliance by all concerned.


