

Edge-EV LIMITED WARRANTY

Manufacturer: Edge-EV

Effective Date: June 1, 2025

Go Fast Motor Sports (“Edge-EV”) warrants Edge-EV golf carts and batteries against manufacturing defects in materials and workmanship for a period that starts from the date of the original retail purchase through an authorized dealer.

Coverage Period:

- **Parts:** 2 years from the date of purchase or delivery to the customer.
- **Battery: Lifetime Full Replacement Warranty** (see details below).

Coverage Details:

Parts Warranty:

Edge-EV warrants that all parts of the vehicle will be free from defects in materials or workmanship for a period of 2 years. This warranty covers manufacturing defects only on non-wearable parts and **excludes:**

- Damages caused by improper use, handling, or maintenance by the dealer or customer.
- Parts that fail due to accidents, misuse, neglect, or unauthorized modifications.
- Damage resulting from alterations or modifications by dealers that cause defects or failures.

Battery Warranty Terms (LIFETIME COVERAGE):

Edge-EV is dedicated to providing reliable and high-performing batteries for your vehicles. Effective June 1, 2025, all lithium batteries now include a **Lifetime Full Replacement Warranty**, covering both the Battery Management System (BMS) and battery cells.

Coverage Includes:

- Full replacement for any manufacturing defect in materials or workmanship.

Important Terms:

- **Non-Transferable:** This warranty is valid only for the original purchaser and cannot be transferred.

- **Registration Required:** Battery **must be registered on the Edge-EV website** within 30 days of delivery to activate the warranty.
- **Shipping & Installation Not Covered:** Warranty covers the **battery only**. It **does not include** shipping, labor, or installation fees.
- **Charger Not Covered:** This warranty does **not** apply to chargers or charger-related failures.

Warranty Claim Process:

Customers must submit a warranty claim using our support ticket form with proof of purchase and documentation (photos/videos). If approved, Edge-EV will issue a replacement battery at no charge for the part itself.

Warranty Claim Process:

- Customers must submit warranty claims with detailed documentation (including photos or videos) using the official Edge-EV support ticket form.
- Edge-EV will evaluate all claims to determine coverage under this policy.
- Approved claims will be processed for repair or replacement at no charge for the defective part.

Exclusions:

This warranty does **not** cover:

- Routine maintenance, wear-and-tear items (e.g., tires, brakes).
- Damage caused by customer or dealer negligence, misuse, or unauthorized modifications.
- Failures caused by not following Edge-EV's maintenance guidelines.
- Charger damage or malfunction.
- Incidental or consequential damages resulting from defects.
