Build Sheet Data	Provides detailed option package information including engine, transmission, trim and paint details on specific loss vehicles to assist with accurate vehicle valuations for designated vehicles.
Fee Calculator Services	Provides fees associated with a total loss claim for automobiles (excluding specialty automobiles), trucks (up to one ton), sport utility vehicles, or vans that would be paid to the vehicle owner as part of the total loss settlement.
Fee Calculator Services – Motorcycles	Provides fees associated with a total loss claim for certain motorcycle classes as determined by CCC that would be paid to the vehicle owner as part of the total loss settlement.
Automated Taxes	Provides taxes associated with a total loss claim for automobiles (excluding specialty automobiles), trucks (up to one ton), sport utility vehicles, certain motorcycle classes as determined by CCC, or vans that would be paid to the vehicle owner as part of the total loss settlement.
Settlement Tracking	Access to track milestones regarding settlement of insureds' and third- party claimants' total loss claims to provide total loss adjusters visibility into their settlement progress and provide customer with cycle time data on total loss settlements based up customer configuration.
Salvage Assignment	Transmission, cancellation and reassignment of salvage assignments to salvage vendor(s) of customer configuration as well as access to salvage assignment status updates and events to and from the Salvage Vendors.
Total Loss vs Repair (TvR) Calculator	Access to a TvR calculator, which includes the ability to receive a salvage quote from select salvage vendors and based on customer configuration, to assist with Total Loss decisioning.
Vehicle Valuations CRV	Written vehicle valuations based on current market data for total loss (ii) large trucks (more than one ton), tractors, RVs, trailers, travel trailers, construction equipment, farm machinery, conversion vans, specialty automobiles and vehicles (e.g., limited production vehicles, muscle cars, collectibles, restorations, exotic and high-end luxury automobiles), manufactured housing (modular homes), personal watercraft, boats, snowmobiles, motorcycles and branded title.
Vehicle Valuations PPV	Written vehicle valuations based on current market data for total loss automobiles (excluding specialty automobiles), trucks (up to one ton), sport utility vehicles and vans as well as the ability to authorize its direct repair program repair facility participants and independent appraisers to submit to vehicle valuation requests.
Guidebook	Access to select guides vehicle values (when available) in a separate section of the valuation report to act as a reference point for vehicle valuations.
External Title Data	Provides title history on vehicle valuations based on internal and select partner data.
