- Incentive & Program Management: Manage the application process for project incentives, such as state-level programs (e.g., Maryland Community Solar, Virginia Shared Solar, Maryland CPCN) or federal grants.
- **Project Diligence:** Maintain meticulous project records, respond to diligence requests, and support the finance/leadership team in project-level financing and sales.
