For the districts of Bear Creek, White River, and Wabash Valley, replenishment will be handled through home delivery. **Orders must consist of 25+ cases to qualify.**

RETURNS REMINDER

For the first time in years, Units may bring back unsold product at the end of the sale. There are, however, some stipulations that must be met. To be eligible for returns, a Unit must have **at least 10**% of their sales in Heroes & Helpers. If this criteria is met, Units may return up to 10% of their invoice. Units will submit their return order by October 26. On October 30, Units will bring returns to Shorr at 9901 Kincaid Drive, Suite 350, Fishers, IN 46037.

Note: Only unopened full cases will be accepted on Return Day.

UNIT TIPS & TRICKS

Online Sales

Make the most of your online page: Leverage the Trail's End app to feature your Scout's online page. Customers can order straight from there and get products delivered, which saves you from dealing with delivery.

Create fun video content: Encourage Scouts to shoot a quick video sharing their enthusiasm for Scouting and how the popcorn sales will help their unit. Post these videos on social media.

Share progress updates: Keep everyone on social media updated with regular news on your Scout's or unit's progress towards their target. You might want to add a visual element, like a map showing sales by state, to boost engagement.

Boost your social media presence post regularly: Share a post about the sale once or twice each week to maintain visibility for the fundraiser without overwhelming your audience.

Post at strategic times: Share posts in the early morning (around 9 a.m.) or in the early evening (approximately 6 p.m.) for the best visibility. Always add a photo or video: Posts that feature visual content generally perform better than those that are text-only.

Keep family and friends in the loop: When a purchase is made, publicly acknowledge the customer in the post to inspire others. Tag supporters: When expressing thanks, tag individuals in your social media posts to extend your reach to their networks.

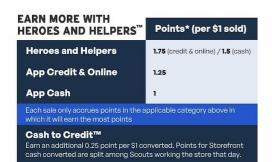
