

# **EU Blue Card News: Latest Updates**

The EU Blue Card—the EU's flagship work-and-residence permit for highly skilled non-EU nationals—underwent major reforms in 2025, marking one of the most substantial updates since its launch. Building on the revised 2021 Blue Card Directive, now implemented across Member States, the changes aim to attract global talent and address labour shortages in key sectors such as IT, engineering, healthcare, and AI. The new framework lowers eligibility thresholds, speeds up processing, and strengthens intra-EU mobility, making it easier for employers to hire and for professionals to relocate and develop their careers across Europe. In addition, the Directive requires Member States to submit, by 18 November 2025 and annually thereafter, detailed statistics on Blue Cards issued, refused, and withdrawn, including the reasons for those decisions.

# **Key 2025 EU Blue Card Reforms**

## 1. Lower Salary Thresholds

Eligibility now requires a salary between 1.0 and 1.6 times the national average (previously 1.5–2.0), broadening access to mid-level professionals. Shortage occupations may qualify at the lower range.

#### 2. Flexible Qualification Requirements

Applicants may qualify with either a master's degree or 3–5 years of relevant professional experience. In-demand fields such as IT and cybersecurity no longer require a formal degree.

### 3. Shorter Employment Contract Requirement

A binding job offer of just 6 months now meets eligibility criteria (previously 12 months).

#### 4. Enhanced Intra-EU Mobility

Blue Card holders can move to another EU country after 12 months (previously 18) without the need for additional labour market tests.

## 5. Greater Employment Flexibility

Easier employer changes after 12 months, plus a 3-month grace period in cases of unemployment during the first three years.

#### 6. Improved Family and Travel Rights

Immediate family reunification and permission to stay up to 12 consecutive months outside the EU without losing Blue Card status.

#### 7. Faster Route to Permanent Residence

Blue Card holders may obtain permanent residence after 33 months, or 21 months if they demonstrate B1-level language proficiency.

These reforms significantly enhance the EU Blue Card's competitiveness on the global stage, with countries such as Germany, France, Poland, and Luxembourg already reporting faster application processing and increased employer participation.

# **Country-Specific Updates and 2025 Salary Thresholds**

To align with the new Directive and address national labour market needs, several EU member states have revised their Blue Card salary thresholds and procedures in 2025.
