Terms & Conditions

Please read these terms and conditions carefully before entering the prize draw. By entering, you confirm that you have read, understood, and agree to be bound by these terms and conditions.

1. The Promoter

3.21. The Promoter is the sole operator of the registration page and the sole collector of entry data. No entry data is collected by GLL, The Capital Hotel & Apartments, The Westminster Hotel, or any other promotional partner.

3.3. (b) Travel insurance (the winner is strongly advised to obtain appropriate travel insurance);

(c) Meals, beverages, room service, minibar, spa treatments, or any other hotel extras or incidentals unless expressly stated;

(d) Airport or station transfers, taxis, or local transport;

(e) Visa fees, passport costs, or any other travel documentation;

(f) Any personal expenses or costs not expressly included in Clause 4.1; or

(g) Any costs incurred by the winner or their guest in travelling to the departure point or from the arrival point.

4.3. The prize must be redeemed within six (6) months of the draw date, subject to availability at both hotels and on Eurostar services.

5.4. The Promoter's decision is final and no correspondence or discussion will be entered into regarding the outcome of the draw.

6. Winner Publication

6.1. 7.42. GLL, The Capital Hotel & Apartments, and The Westminster Hotel will not have access to the Promoter's entry database and will not receive entrants' personal data for marketing purposes.

7.43. For the avoidance of doubt: although The Capital Hotel & Apartments and The Westminster Hotel are promoting the prize draw to their own databases and mailing lists, this promotional activity is separate from the Promoter's entry database. 11.3. If any provision of these terms and conditions is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

11.4. A person who is not a party to these terms and conditions has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of these terms and conditions.

11.5. These terms and conditions, and any non-contractual obligations arising out of or in connection with them, shall be governed by and construed in accordance with the laws of England and Wales.
