We are excited to announce that GoldCare will be offering in-person patient primary and specialty care services for GoldCare members across the country through our new GAP Program!

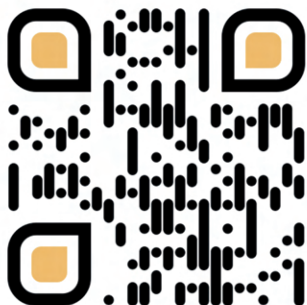
The Pilot Program will Lead the Way

What is the GoldCare Affiliate Program?

The GAP Pilot Program will consist of a limited number of Direct Primary Care (DPC) & Specialty Care clinicians selected by GoldCare. This small group will work together to assist with finalizing the program design before we do a full rollout to the entire country. Are you interested in helping us build the path forward? GoldCare does not want to build clinics in communities. We desire to align with existing like-minded, non-MIC DPC & Specialty practices for the mutual benefit of the Clinicians, GoldCare, and members of both entities.

Why join?

This is an opportunity for us to work together to restore medical freedom, and for you to see GoldCare members that may also choose to join your clinic to help ensure the independence of your practice. As we grow the GoldCare Affiliate Program, Pilot Program Clinicians will be able to establish their practices and grow before we add additional practices. We will ensure that new growth is not at the expense of those clinicians who are already part of the GoldCare family.

What does it cost to join the Pilot Program?

There is no cost to join GoldCare's Pilot Program. The benefits of membership are mostly for your members and therefore, the costs are primarily paid by the members recruited by the DPC or Specialty Clinician. The expectations of the GAP Pilot Program Participants include:

- Join the GoldCare Private Member Association (PMA) — monthly membership fees are waived for Clinicians and their immediate family members under age 26.
- Attend a two hour orientation of the GoldCare platform.
- Encourage and offer GoldCare enrollment in your clinic using the marketing templates personalized to you and your business. Any member brought to GoldCare through the GAP Clinician will be permanently "attached" to the clinician until GoldCare membership is canceled.
- Determine your consultation fee, and accept GoldCare members for on-site, as needed care (under mutually agreed upon terms) when GoldCare members accept the referral.
- Communicate directly with the GoldCare GAP Leadership Team to assist with finalizing the design of GoldCare's GAP Program for a successful national rollout.
- Communicate with other GoldCare GAP Pilot Program Clinicians to assist each other with the successful growth of your clinics.
