**Orientation:** My therapeutic orientation is eclectic with a strong cognitive-behavioral emphasis. The general areas that I believe important for healthy emotional functioning include the recognition and acceptance of one's own feelings, needs and behavior; finding new ways to conceptualize means that allow you to feel better or act more efficaciously; actively making choices which best meet your needs from the alternatives available to you; and taking responsibility to actively and assertively (versus passively or manipulatively) implement your choices. I strongly believe in the importance of action and trying new behaviors versus inaction and introspection. Over the years I have become increasingly appreciative of the critical role of physiology in emotional/personality functioning. As a result I see psychotropic medications as a vital part of treatment planning for individuals with mood disorders, anxiety disorders, impulse control disorders and ADHD.
