HOW TO PURCHASE CITY-OWNED PROPERTY

I. Submit A Letter of Interest (LOI)

Identify a city-owned vacant lot and or property. Complete the Letter of Interest application. Applications and instructions can be obtained from our website, and from The City of Gary, Department of Redevelopment Office.

IMPORTANT: ALL COMPLETED LOI FORMS MUST BE EMAILED TO REDEVELOPMENT@GARY.GOV FOR PROPER PROCESSING

II. Property Availability

Once you submit your LOI, you will receive a formal written reply within 90 days from your application submission. If the property is available, you may be asked to schedule a meeting for further review.

IMPORTANT: SUBMISSION OF AN LOI DOES NOT GUARANTEE THE PROPERTY WILL BE ISSUED TO YOU

III. Next Steps

- A. Proposed projects will be reviewed by the Executive Director of Redevelopment. The Department of Redevelopment reserves the right to request additional information from all applicants.
- B. The legislative process will begin so that an agenda date can be set for the Board of Commissioners to vote on the redevelopment agreement for the proposed project. It may take up to 90 days for a project to be scheduled on the Board of Commission's agenda.
- C. Commission Vote. All sales of City-owned property must be approved by the Gary Redevelopment Commission.
- D. Following the vote, the redevelopment agreement timeline commences.
