BACKGROUND AND PURPOSE

The mission of this new grant program is to fund highly meritorious research projects that utilize the data deposited in the Gray BRCA Pre-Cancer Atlas (the Atlas). The Atlas is a developing unified resource capturing the molecular, genetic, and physiological changes occurring at the earliest signs of BRCA-associated cancer. Thanks to the collaborative work of multiple research groups, many aspects are already publicly available (see public facing site - <https://www.graybrcaatlas.org/>), including the integration of newly developed single cell and spatial profiling technologies with histology and 'omics approaches. The Gray Foundation is now seeking new proposals on innovative ways to analyze and utilize these data to develop new ways to combat BRCA-related cancers. The funding will be for a period of up to 2 years with a budget of up to \$250K/year. The Foundation is willing to consider multiple applications from the same institution.

ELIGIBILITY AND REVIEW CRITERIA

- Investigators must hold a medical or other doctoral degree and have a faculty appointment at an academic, medical, or research institution equivalent to an Assistant Professor, or higher.
- Applicants must be academic, medical, or research institutions anywhere in the world.
- For-profit enterprises are not eligible to apply but may be listed as Collaborators. However, no grant funds may be directed to collaborators working within a for-profit entity.
- Questions about eligibility should be sent to the Gray Foundation (grants@grayfoundation.org) prior to submitting a Letter of Intent (LOI).

REVIEW PROCESS

The Gray Foundation will review all LOIs submitted and will invite selected applicants to submit full proposals. Decisions on LOIs will be provided by the end of January 2026, and more details regarding full proposal submission and deadlines will be provided at that time. Invited full proposals will be reviewed by the Gray Foundation Scientific Committee, which will provide recommendations for funding.

The following criteria will be considered for each application (**see details in program guidelines**):

- Connection to the Atlas
- Innovation
- Significance
- Approach
- Clinical/Translational Potential
- Investigators/Team/Environment

Letters of Intent (LOI) are due by 12:00 pm (noon) United States Eastern Time on January 9, 2026. Please submit proposals to: grants@grayfoundation.org. Confirmation of receipt will be emailed within 1 business day. Please contact us if you do not receive a confirmation.

- Investigator Information/Signature form (see below)
- Project Description Form (see below, 2 pages, 12pt font). Must include: title, lay summary, background and rationale, specific aims, research design and methods, innovation, Team description
- References (1 page)
- NIH Biosketches
