BUILDING ASSESSMENT FOR NEW MEMBERS: THE LINKS FOUNDATION, INCORPORATED

As you are aware, effective for new members/candidates inducted in 2025 and thereafter, the \$600 Building Assessment must be paid, **prior** to her induction. The current chapter process for new member intake will remain the same, with this exception:

The candidate(s) is /are to write **one check (payable to The Links Foundation, Incorporated) for \$600**. The chapter treasurer will send all approved candidates, and their individual checks combined to the following address:

At this time, there is no option for a candidate to pay the \$600 electronically to national headquarters. The building assessment for new members **MUST** be received at national headquarters no later than 35 days prior to the scheduled induction date.

The chapter treasurer will continue to pay a candidate(s) Links Incorporated and The Links Foundation, Incorporated dues/fees electronically via the MMS system, after collection from the candidate (s).

REINSTATING MEMBERS: THE LINKS, INCORPORATED and THE LINKS FOUNDATION, INCORPORATED

The dues and fees for former members who have been approved for reinstatement should follow the payment chart above for Current Active members. Reinstating members do not pay new member fees regardless of how long they've been separated from the organization.

Former members who are reinstating are required to pay (see Bylaws of The Links, Incorporated, Article I Section 12):

- A reinstatement fee of \$500.00.
- The \$600.00 building assessment or any remaining balance. This must be paid in full prior to reinstatement.
- Current chapter, area, and national (The Links, Incorporated and The Links Foundation, Incorporated) dues and assessments.
- All chapter and area dues and assessments owed at the time of their forfeiture of membership.
- All national dues and fees must be electronically submitted by the chapter treasurer at least 35 days prior to the former member's return.
