Divorce & Financial Support	Full support with the divorce procedure (below) plus assistance in negotiating and resolving financial/assets issues, and managing communication with the other party or their solicitor.	£750 *

Order	Description	Fee (£)
Consent Order	Drafting and finalising an order that reflects an already-reached agreement (e.g., via mediation). Ensures the agreement is formally recorded and legally binding.	£300
Consent Order + Statement of Information & Pension Sharing Annex	Everything included in the standard Consent Order, plus completing the Statement of Information (SOI) and Pension Sharing Annex (PSA). Requires up-to-date pension valuations.	£400
Child Arrangements Order	Preparing required documents to set out where a child will live, who they spend time with, and how contact is managed.	£250

Pre/Post-Nuptial Agreement	Detailed provisions, dispute resolution clauses, and tailored terms for more intricate needs.	£400 From £600 (Negotiated) *
Non-Disclosure Agreement (NDA)	Protects sensitive information from unauthorised use or disclosure.	From £275
Cohabitation Agreement (Basic)	Covers fundamental financial/personal arrangements for unmarried couples living together.	£350
Cohabitation Agreement (Complex)	More detailed financial arrangements, including multiple assets or unique financial considerations.	From £400
Parental Responsibility	Grants an unmarried father, step-parent, or other individual legal rights and responsibilities for a child.	From £200
Child Maintenance Agreement	<p>Sets out agreed financial contributions for the care and upbringing of a child, including payment amounts, frequency, and review arrangements.</p> <p>This is a private agreement and is not enforceable through the Child Maintenance Service unless separately registered.</p>	£250
