- 1. Eligibility is only the Contractors that have been successfully registered under the Authority's Civil Works Registry FY2024/25 Cat A for Upolu.
- 2. The Works generally shall consist of the following list of activities which is not exhaustive:
  - Tropicana Bridge A full structural upgrade or replacement of the existing bridge is required to enhance load-bearing capacity, improve safety, and support heavy vehicle traffic. The proposed works include the construction of new abutments to accommodate a Modular Panel Bridge Compact 200 with a span of 36 meters (center-to-center bearings), including a 1.5-meter-wide footpath on the downstream side to improve pedestrian access and overall functionality or structure equivalent.

Civil works including but not limited to concreting, earth works, guard rails installations, rock excavations, road pavement works, etc.

- 5. The Pre-Bid meeting to convey information on the scope and tender requirements of the works will be held at the LTA Board Room at 11:00am on 5<sup>th</sup> September 2025.
- 6. All bids must be delivered to the Office of the Secretary of the Tenders Board, Ministry of Finance, Level 4, Apia, at or before 11:00am on 6<sup>th</sup> October 2025. Late bids will not be accepted.
- 7. All bids must be accompanied by a Bid-Securing Declaration as specified in the bidding documents, ITB 19.1.

Bids will be opened immediately thereafter in the presence of any bidders' representatives who choose to attend.
