Negative screening considers three layers of law: 1) native title, 2) other statutory indigenous title and 3) cultural heritage protection legislation. Case Study: Project Energy Connect – electricity transmission line from New South Wales to South Australia crossing 20 different First Nations lands. CEFC has committed to \$295 million with 2.5% of the value of its engineering, procurement and construction contracts allocated to a First Nations workforce. Tom Widdup – First Nations Heritage Protection Alliance</p> <p>In November 2021 the alliance signed an agreement with the Commonwealth to co-design a reform process around cultural heritage protection. The first round of consultations with stakeholders are set to begin in the coming weeks. Investors will be considered stakeholders.</p> <p>The Alliance calls on investors as allies to ensure the government gets a strong indication from the investment sector that there is strong support to reform cultural heritage protection laws. Collaborate with First Nations Peoples’ to increase their voices in responsible investment and sustainable finance</p> <p>The last bi-annual leaders meeting between RIAA and the First Nations Heritage Protection Alliance highlighted the relationships and trust that is being built. It also facilitated a quick response from the investor side regarding the WA cultural heritage bill. The press release attracted significant attention.</p> <p>This meeting and the advocacy serve as a reminder of not only the need for reform but an overall shift in national consciousness. The priorities are Dhawura Ngilan Business and Investor Initiative and the Commonwealth legislative reform.</p> <p>2. The Gurindji Story

Many people will know our story from the iconic song, *From Little Things Big Things Grow*

But we invite the RIAA to dig a little deeper. This is how we Gurindji tell it...



DISPOSSESSION

For tens of thousands of years, we Gurindji people lived and thrived in our homelands in the heart of what is now known as the Northern Territory.

When whitefellas arrived and began to occupy Gurindji Country in the late 1800s, bringing cattle and horses with them, immense pressure was placed on our traditional way of life.

Clashes ensued, awful massacres took place and, ultimately, the pastoralists exploited the Gurindji to work on their cattle station under conditions akin to slavery.

This shameful abuse of our people (and many others like us across Australia) went on for some 80 years.



THE WAVE HILL WALK-OFF

In the mid 1960s, Gurindji leader Vincent Lingiari said enough is enough. No longer would he and our people toil in such dismal poverty on the Wave Hill Cattle Station (owned by the British Lord Vestey).

The incredibly brave decision was made to walk off the job, demanding they receive fair wages and conditions before they returned.

However, what began as a wages dispute, soon became a battle for something much bigger: we Gurindji decided we didn't want Vestey's jobs even if things improved; we now wanted to rightfully reclaim our land.

"We want to live on our land, our way," said Vincent.



OUR WIN THAT CHANGED THE NATION

Despite constant pressure, intimidation and threats, the Gurindji held strong. Even when the powers that be tried everything to break our resolve, to isolate us, to drive us to starvation, still we waited and waited.

The courage and determination this took – especially at that time in history – is difficult to comprehend.

After nine long years, in a watershed moment that forever changed race relations in Australia, we Gurindji won. And that famous photograph of Prime Minister Gough Whitlam ceremonially offering Vincent a handful of earth still resonates today.

The Gurindji's bravery and resolve sparked the Aboriginal Land Rights movement and created a brighter future for all First Nations people.



THE GURINDJI LEGACY

Over the last 50 years, the heroic Gurindji story has become the subject of films, documentaries, books and songs. We are celebrated widely for our years-long fight for self-determination and the birth of Land Rights.

We remain an enduring symbol of hope for many Aboriginal & Torres Strait Islander people.

The 200 Gurindji stockmen and their families who stood up to power and won, should always be remembered as true heroes.

In their honour, we gather on Gurindji Country every August to commemorate and celebrate them at the Gurindji Freedom Day Festival.
