DOCUMENTS REQUIRED WITH APPLICATION:

- 1. Certified copies of identity document for bride and groom.
- 2. Certified copies of both witnesses identity documents.
- 3. Contract (if not In community of property).
- 4. Certified copy of divorce or death certificate (if applicable).
- 5. Supply 3 ID photo's of the bride and the groom.
- 6. Proof of residence.
- 7. A person without a South African ID needs to fill in a DHA-31 (this will be done by the parish office).

REQUIREMENT FOR FOREIGNERS:

- A letter from your country of origin stating that you are not married in your country.
- 2. Verification from embassy.
- 3. Bring passport with valid permit at least 30 days.
- 4. Both parties should go for an interview at immigration in order to give permission for wedding to take place.

Finger prints will be taken as it is required by the Department of Home Affairs.

(All expenses incurred by the office and marriage officer must be reimbursed in the form of a donation).
