## TAKECONTROL SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

**1. PROMOTION DESCRIPTION**: The TakeControl Sweepstakes ("Sweepstakes") entry period begins on August 1, 2025, at 08:00 AM PST and ends on September 17, 2025, at 11:59 PM PST (the "Promotion Period"). All entries must be received during the Promotion Period to be eligible.

The sponsor of this Sweepstakes is FloQast, Inc. ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these official rules ("Official Rules") and the decisions of Sponsor, which shall be final and binding in all respects, and you represent and warrant that you meet the eligibility requirements of the Sweepstakes.

Sponsor is responsible for the collection, submission or processing of entries and the overall administration of the Sweepstakes. 2. ELIGIBILITY: Open to individual legal residents of the 50 United States, the District of Columbia, or Canada (excluding the province of Quebec) who are at least the age of majority in their state, province, or territory of residence at the time of entry (the "Entrant" or "you"). Sponsor, and its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies, partners and each of their respective officers, directors, and employees (the "Promotion Entities"), are ineligible to enter the Sweepstakes or win a prize.   - **Method 2: Alternative Method of Entry (**"*AMOE*"**)** Complete the online entry form at <a href="http://bit.ly/46XzkZV">http://bit.ly/46XzkZV</a> during the Promotion Period. AMOE Entrants are eligible for Tier 1 prizes only.

Limit of one entry per person regardless of entry method. Automated or robotic entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Any attempt by Entrant to obtain more than one entry by using multiple/different email addresses, identities, registrations, logins, or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant's entries and that Entrant may be disqualified. The random drawings will be conducted within one week after the TakeControl event by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible Entrants in each tier. Participants may only win one prize, with higher tier prizes taking precedence.
