

TAKECONTROL 2026 FCA CERTIFICATION SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. PROMOTION DESCRIPTION: The TakeControl 2026 FCA Certification Sweepstakes (“*Sweepstakes*”) entry period begins on July 21, 2026 at 08:00 AM PST and ends on September 17, 2026 at 11:59 PM PST (the “*Promotion Period*”). All entries must be received during the Promotion Period to be eligible.

The sponsor of this Sweepstakes is FloQast, Inc. (“*Sponsor*”). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these official rules (“*Official Rules*”) and the decisions of Sponsor, which shall be final and binding in all respects, and you represent and warrant that you meet the eligibility requirements of the Sweepstakes.

Sponsor is responsible for the collection, submission or processing of entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes. Sponsor may be reached at <https://floqast.com/contact/> during the Promotion Period.

2. ELIGIBILITY: Open to individual legal residents of the 50 United States or the District of Columbia who are at least the age of majority in their state of residence at the time of entry (the “*Entrant*” or “*you*”). Entrants must be current customers of Sponsor or any of its subsidiaries or affiliates at the time of entry. For purposes of these Official Rules, a “current customer” means any individual whose employer or organization maintains an active paid subscription to any Sponsor product or service as of the date of entry. Sponsor reserves the right to verify customer status in its sole discretion.

Sponsor, and its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies, partners and each of their respective officers, directors, and employees (the “*Promotion Entities*”), are ineligible to enter the Sweepstakes or win a prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. “Household Members” shall mean those people who share the same residence at least three months a year. “Immediate Family Members” shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited or

restricted by law. Participation constitutes an Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes.

3. PRIZES:

One (1) winning team will be selected. The winning Entrant and up to 15 members of their team at the same company or organization (collectively, the "*Winning Team*") will receive the following Prize:

- (a) An on-site FloQast Certified Accountant ("*FCA*") certification training experience, consisting of one (1) full training session, conducted at the Winning Team's office location within the continental United States. Upon successful completion of the training, each Winning Team member will receive FCA certification with no exam required.
- (b) A premium social experience for the Winning Team, which may include a team dinner and a group entertainment outing in the Winning Team's city. The specific social activities will be determined by Sponsor in its sole discretion.

The estimated approximate retail value ("*ARV*") of the Prize is \$2000 ARV, based on a Winning Team size of 10. The final ARV is subject to change based on the actual size of the Winning Team. However, in no event will the ARV exceed \$5,000. The ARV consists of the social experience components described in subsection (b) above.

All federal, state, and/or local taxes, fees, and surcharges on the Prize are the sole responsibility of each member of the Winning Team. For any Winning Team member whose individual share of the prize value is \$600 or more, such member will be required to provide a completed IRS Form W-9 prior to prize fulfillment, and Sponsor will issue an IRS Form 1099-MISC for the applicable prize value.

Prizes will only be awarded and/or delivered to addresses within the 50 United States or the District of Columbia. Prizes cannot be transferred, redeemed for cash, or substituted by a winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the Prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the Prize turns out to be less than the stated ARV, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety, or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not

replace any lost or stolen prize items. Failure to comply with the Official Rules will result in forfeiture of the Prize.

4. HOW TO ENTER: There are two ways to enter this Sweepstakes during the Promotion Period:

- **Method 1: Event Entry** – Complete the following steps during the Promotion Period: (a) register for the TakeControl 2026 event at <https://www.floqast.com/takecontrol>; and (b) earn at least three (3) CPE credits during the TakeControl 2026 event. Upon completion of both steps, your entry will be automatically submitted for this Sweepstakes.
- **Method 2: Alternative Method of Entry (“AMOE”)** – Complete the online entry form at [this link](#) during the Promotion Period. No event registration, attendance, or CPE credits are required for AMOE entry. AMOE Entrants are eligible for the same Prize as Event Entry Entrants.

Limit of one entry per person regardless of entry method. Automated or robotic entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Any attempt by Entrant to obtain more than one entry by using multiple/different email addresses, identities, registrations, logins, or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant’s entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All entries must be posted by the end of the Promotion Period in order to participate. Sponsor’s database clock will be the official timekeeper for this Sweepstakes.

5. WINNER SELECTION: One (1) winner will be selected in a random drawing from among all eligible entries received during the Promotion Period. The random drawing will be conducted within one week after the TakeControl 2026 event by Sponsor or its designated representatives, whose decisions are final. Odds of winning will depend on the number of eligible entries received.

6. WINNER NOTIFICATION: The winner will be notified by email at the email address provided at the time of entry within approximately 72 hours after the random drawing. The potential winner must accept the Prize by email as directed by Sponsor within five (5) business days of notification. The potential winner must also provide the names and email addresses of the Winning Team members within ten (10) business days of notification, up to the maximum specified in Section 3. Each Winning Team member must meet the eligibility requirements set forth in Section 2 and may be required to sign and return an affidavit of eligibility, release of liability, and publicity release. Sponsor is not responsible for any delay or failure to receive

notification for any reason, including inactive email account(s), technical difficulties associated therewith, or a potential winner's failure to adequately monitor any email account.

The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a publicity release. No substitution or transfer of a prize is permitted except by Sponsor.

If a potential winner or Winning Team member: (a) cannot be contacted; (b) fails to respond within the specified time period; (c) fails to return the required documents within the specified time period; (d) is found to be ineligible; (e) fails to comply with these Official Rules; or (f) if the prize or prize notification is returned as undeliverable, that potential winner will be disqualified and will forfeit the Prize. In the event a potential winner is disqualified for any reason, Sponsor will award the Prize to an alternate winner selected by a random drawing from among all remaining eligible entries. This process will be repeated up to three (3) times, after which the Prize may go unawarded if it remains unclaimed.

7. PRIZE FULFILLMENT AND DELIVERY: Following successful verification, the Sponsor will coordinate directly with the winning Entrant and the Winning Team to schedule the on-site FCA certification training and social experience. The Prize must be redeemed within six (6) months of winner notification. The Winning Team must provide a suitable conference room or training space at their office location. Sponsor will arrange all travel for Sponsor's personnel to the Winning Team's office. The specific dates for the training and social experience will be mutually agreed upon by the Sponsor and the Winning Team, subject to Sponsor's personnel availability. If the Winning Team is unable to accommodate the on-site visit within the six (6) month redemption window, the Prize will be forfeited and no substitute or cash equivalent will be provided.

8. PRIVACY: Any personal information supplied by you will be subject to the privacy policy of the Sponsor posted at <https://floqast.com/privacy-policy/>. By entering the Sweepstakes, you grant Sponsor permission to share your email address and any other personally identifiable information with the other Promotion Entities for the purpose of administration and prize fulfillment, including use in a publicly available winners list. Winners lists may also be shared with state regulatory agencies as required by applicable law.

9. LIMITATION OF LIABILITY: Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, camera,

computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of any network or wireless service, the Internet or website or any combination thereof; (e) suspended or discontinued Internet, wireless or landline phone service; or (f) any injury or damage to participants or to any other person's computer or mobile device which may be related to or resulting from any attempt to participate in the Sweepstakes or download of any materials in the Sweepstakes.

If, for any reason, the Sweepstakes is not capable of running as planned for reasons which may include without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. In such an event, Sponsor shall immediately suspend all drawings and prize awards, and Sponsor reserves the right to award any remaining prizes (up to the total ARV as set forth in these Official Rules) in a manner deemed fair and equitable by Sponsor. Sponsor and the Promotion Entities shall not have any further liability to any participant in connection with the Sweepstakes.

10. DISPUTES AND GOVERNING LAW: Except where prohibited, each Entrant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate federal or state court located in Los Angeles County, California; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (c) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the Entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules.

11. PUBLICITY AND RIGHTS OF PUBLICITY: Except where prohibited by law, participation in the Sweepstakes constitutes each winner's consent and grant to Sponsor (and its subsidiaries, affiliates, and authorized agents) of an irrevocable, perpetual, worldwide, non-exclusive license to use the winner's name, city, state/province, likeness, photograph, voice, and statements for any and all promotional, advertising, and other purposes in any and all media, now known or hereafter devised, without further compensation, notification, or permission.
