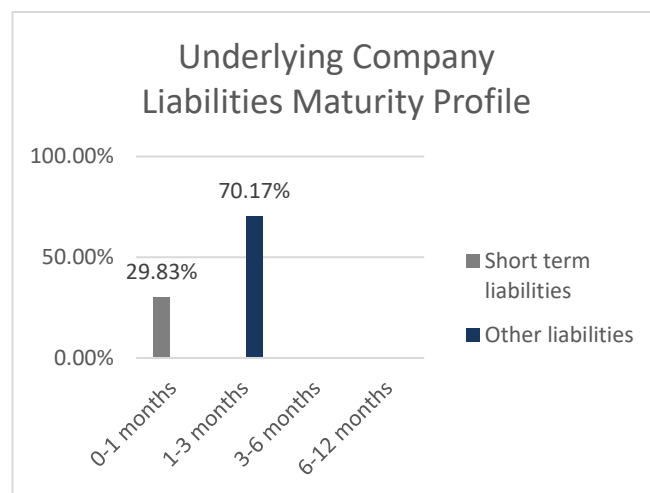
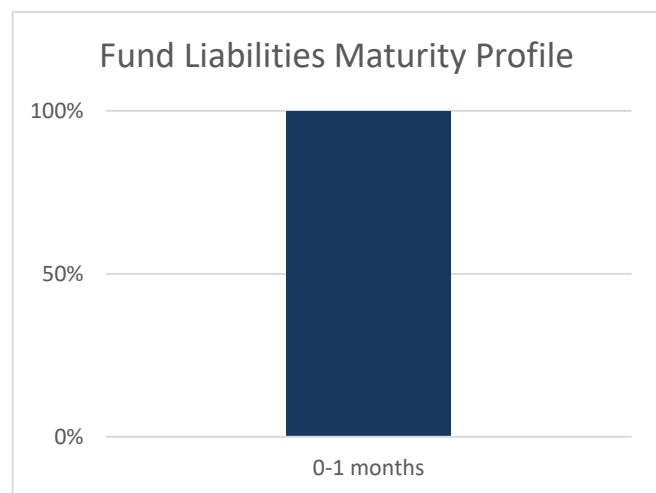
Fund Strategy
