

Affiliate Program

Terms and Conditions

These Terms and Conditions (the “Terms”) govern the relationship between PD Data Solutions AB (“PD Data Solutions”, “PropsData.io”, “we”, “us”) and any individual or entity participating in the PropsData.io Affiliate Program (the “Affiliate”, “you”).

1. Independent Contractor Status — No Employment

Affiliates act as **independent contractors** and not employees of PD Data Solutions AB. **No employment relationship, partnership, joint venture, agency, or franchise** is created between the Affiliate and PD Data Solutions AB by virtue of these Terms or participation in the Affiliate Program. The Affiliate has no authority to bind, represent, or act on behalf of PD Data Solutions AB in any manner.

2. Taxes, Social Fees, VAT and Reporting Obligations

The Affiliate is **solely and exclusively responsible** for all taxes, social security contributions, social fees, VAT (value added tax), income tax, self-employment tax, and any other levies, charges, or reporting obligations arising in their jurisdiction in connection with commissions or other compensation received under the Affiliate Program.

PD Data Solutions AB does not withhold taxes, social security contributions, or employer contributions on behalf of the Affiliate, and will not issue payslips, employment certificates, or any documentation implying an employment relationship. It is the Affiliate's own duty to register with the relevant tax authorities, declare income, and comply with all applicable accounting and reporting requirements.

3. Eligibility

To participate in the Affiliate Program, the Affiliate must be at least 18 years of age (or the age of majority in their jurisdiction, whichever is higher) and legally capable of entering into a binding agreement. Affiliates must comply with all applicable laws and regulations in their jurisdiction, including, where relevant, gambling and gambling-advertising laws, consumer protection laws, and marketing laws.

PD Data Solutions AB reserves the right to refuse, suspend, or terminate any Affiliate's participation in the program at its sole discretion.

4. Affiliate Obligations

The Affiliate agrees to:

- Promote PropsData.io and its services accurately, lawfully, and ethically.
- Refrain from making misleading, deceptive, or unsubstantiated claims about PropsData.io, its products, or potential returns from sports betting.
- Not target minors or individuals located in jurisdictions where sports betting or related promotion is prohibited.

- Comply with all applicable advertising standards, marketing laws, responsible gambling rules, and platform-specific rules (e.g., social media network terms of service).
- Not use spam, unsolicited communications, malware, cookie stuffing, trademark bidding on PD Data Solutions AB's brand terms, or any other deceptive technique to generate referrals.
- Maintain the confidentiality of any non-public information shared by PD Data Solutions AB.

5. Commissions and Payments

Commission rates, qualifying actions, payment thresholds, and payout schedules are communicated separately and may be updated from time to time. Commissions are paid **gross of any taxes** for which the Affiliate is responsible (see Section 2).

PD Data Solutions AB may withhold or reverse commissions in cases of fraud, chargebacks, refunds, breach of these Terms, or activity that violates applicable law or platform rules.

The Affiliate is responsible for providing accurate payment details and any tax identification information required for cross-border payments. Bank fees, currency conversion costs, and similar charges are borne by the Affiliate unless explicitly stated otherwise in writing.

6. Note for Swedish Private Individuals (Privatpersoner)

For Swedish private individuals who do not operate their own registered business (enskild firma, aktieföretag, or equivalent), we recommend using an **egenanställningstjänst** (umbrella employment service) such as **Frilans Finans**, **Cool Company**, or a comparable provider. These services invoice PD Data Solutions AB on your behalf and handle preliminary tax (preliminärskatt), social fees (sociala avgifter / arbetsgivaravgifter), and reporting to Skatteverket on your behalf.

PD Data Solutions AB is not affiliated with, and does not endorse, any specific provider. Affiliates should consult a qualified tax advisor or Skatteverket directly before making any decision regarding their tax setup.

7. Intellectual Property and Brand Use

PD Data Solutions AB grants the Affiliate a limited, non-exclusive, non-transferable, revocable license to use the PropsData.io name, logo, and approved marketing materials solely for the purpose of promoting the service in accordance with these Terms. All trademarks, trade names, logos, copyrights, and other intellectual property rights remain the exclusive property of PD Data Solutions AB.

The Affiliate must not register, use, or attempt to register any domain name, social media handle, or trademark that is identical or confusingly similar to PropsData.io or PD Data Solutions AB.

8. Confidentiality

Any non-public information shared by PD Data Solutions AB with the Affiliate — including commission structures, performance data, internal tooling, models, statistical methodologies, or business plans — is considered confidential. The Affiliate agrees not to disclose such information to third parties without prior written consent and to use such information solely for the purpose of fulfilling these Terms.

9. Limitation of Liability

To the maximum extent permitted by applicable law, PD Data Solutions AB shall not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits, revenue, data, or goodwill, arising out of or in connection with the Affiliate Program. PD Data Solutions AB's total aggregate liability under these Terms shall not exceed the total amount of commissions paid to the Affiliate during the twelve (12) months preceding the event giving rise to the claim.

PD Data Solutions AB makes no warranties or representations regarding any specific level of earnings or success in the Affiliate Program.

10. Indemnification

The Affiliate agrees to indemnify, defend, and hold harmless PD Data Solutions AB, its directors, officers, employees, and agents from and against any claims, damages, losses, liabilities, costs, and expenses (including reasonable legal fees) arising out of or related to: (a) the Affiliate's breach of these Terms; (b) the Affiliate's marketing or promotional activities; (c) the Affiliate's failure to comply with tax, social security, or reporting obligations; or (d) any claim that the Affiliate is or has been an employee of PD Data Solutions AB.

11. Term and Termination

These Terms remain in effect until terminated by either party. Either party may terminate the Affiliate's participation in the Affiliate Program at any time, with or without cause, by providing written notice. PD Data Solutions AB may also terminate or suspend an Affiliate's account immediately in the event of suspected fraud, breach of these Terms, or violation of applicable law.

Upon termination, the Affiliate must cease all use of PD Data Solutions AB's trademarks and marketing materials. Sections relating to taxes, confidentiality, intellectual property, limitation of liability, and indemnification survive termination.

12. Governing Law and Jurisdiction

These Terms are governed by the laws of Sweden, without regard to conflict-of-law principles. Any dispute arising under or in connection with these Terms shall be subject to the exclusive jurisdiction of the competent courts of Stockholm, Sweden, unless mandatory consumer protection rules in the Affiliate's country of residence dictate otherwise.

13. Changes to These Terms

PD Data Solutions AB may amend these Terms from time to time. Material changes will be communicated to the Affiliate by email or through the affiliate dashboard. Continued participation in the Affiliate Program after such changes take effect constitutes acceptance of the updated Terms.
