Programme Structure

The Accountancy and Finance
Degree Pathway is comprised of
four entry and exit points, providing
students with a set of pathways
to earn their bachelor's degree.
Students are able to combine their
studies with family obligations and/
or a job and create a pathway that
works for their schedule.

How does it work?

Because the programme is made up of different phases, students who enrol in this course get to obtain a fully accredited and globally recognised certificate for each phase that they complete, whilst also earning ACCA exemptions.

One programme, four phases, five certifications

By the end of this programme, students will be in possession of an MQF Level 5 Certificate, an MQF Level 5 Diploma, an MQF Level 5 Foundation Degree and an MQF Level 6 BSc in Accountancy and Finance, awarded by KNIGHTS.

Students will also earn the ACCA Advanced Certificate in Accountancy and Finance.

Progression Opportunities

Learners who complete the full degree pathway will be awarded nine ACCA exemptions. This means that in addition to achieving a globally recognised BSc in Accountancy and Finance, graduates of this programme will also get the chance to fast-track their way to achieving the full ACCA qualification and becoming chartered certified accountants.

Learners will also be able to pursue a master's degree in the field or opt to pursue the ACCA Professional Papers.

Entry Requirements

Applicants must hold a
Matriculation Certificate with
a pass in Pure Mathematics
(Intermediate) and Accountancy
(Advanced), or an MQF Level 4
qualification in a related field.
Proficiency in English (IELTS 5.5 or
equivalent) is also required.
