1. Introduction

B2B PRIME SERVICES BAHAMAS LIMITED (“the Company”, “we”, “us”, “our”, “ours” and “ourselves” as appropriate), is a Company incorporated under the laws of the Commonwealth of The Bahamas, authorized and regulated by the Securities Commission of The Bahamas (SCB) under the Securities Industry Act, 2011 (SIA) and the Digital Assets and Registered Exchanges Act, 2024 (DARE Act), with registered office at Aristo House, Sanford Drive, Nassau, Bahamas, The Bahamas.

We respect your privacy and want you to understand how we collect and use data about you through the use of cookies.

Our Cookies Policy is intended to inform you about why we use cookies, the type of cookies that we use on the website www.b2prime.com, and the options available to manage your preferences.

This Cookies Policy is governed by the Data Protection (Privacy of Personal Information) Act, 2003 of The Bahamas, as amended, as well as guidelines issued by the Office of the Data Protection Commissioner of The Bahamas.

2. What are Cookies

Cookies are small text files created by websites you visit or by certain emails you open, and are placed on your computer or other device. Cookies are used to track, save and store information about the user's interactions and usage of the website in order to improve the user experience, enable functionality on the website, facilitate site security and provide the business with marketing information about the website's visitors.

Cookies do not transfer viruses or malware to your computer. Cookies generally can easily be viewed and deleted and are harmless and serve crucial functions for websites.

3. Cookie Types

- Strictly Necessary Cookies: Essential for basic website operation and secure areas.
- Analytical/Performance Cookies: Collect visitor information (anonymous) for analytics, performance monitoring, and service improvements.
- Functional Cookies: Remember your choices (e.g., language or region).
- Third Party Cookies: Set by third parties, including social media and advertising platforms.

4. Why are Cookies Useful?

Cookies help us provide the functionality you need to browse the Website correctly.

They allow us to:

- Verify your identity and detect which country you are located in.
- Check browser type and device.
- Track referring sites.
- Optimize user experience, personalize content and ads, and monitor performance.

5. Legal Basis and Consent

In compliance with the Bahamian Data Protection Act:

- Strictly necessary cookies: used based on our legitimate interest in ensuring website operation and security.
- Other cookies (performance, functionality, third-party/marketing): only used with your explicit, affirmative consent.

When you first visit our website, a Cookies Notice will appear allowing you to accept all cookies, reject all non-essential cookies, or manage your preferences by category.

6. Duration of Cookies

- Session Cookies: Deleted when you close your browser.
- Persistent Cookies: Remain until their expiry date or deletion.

7. How You Can Remove Cookies

Most browsers allow you to deny, accept, block, or delete cookies. Please note that disabling cookies may affect the functionality of the website. Instructions for cookie management are available for: Google Chrome, Microsoft Edge, Mozilla Firefox, Safari, and Opera.

8. User Rights

As a data subject under Bahamian law, you have the right to:

- Access the personal data collected about you;
- Request rectification or erasure;
- Restrict or object to processing;
- Lodge a complaint with the Data Protection Commissioner of The Bahamas.
