IN 2024, CONSERVATION X LABS COMPLETED THE DESIGN AND FUNDRAISING FOR THE FIRE GRAND CHALLENGE (HTTPS://CONSERVATIONXLABS.COM/FIRE), AFTER HOSTING THE FINAL TWO CONVENINGS OF THE PARTICIPATORY DESIGN PROCESS IN INDONESIA AND CALIFORNIA. FOR THE REST OF THE YEAR, THE TEAM DETAILED THE IMPLEMENTATION PLAN, CONTINUED BUILDING A COALITION OF KEY PARTNERS, EXPANDED FUNDRAISING EFFORTS, AND PARTICIPATED IN OTHER OPPORTUNITIES, SUCH AS HELPING CULTURAL FIRE PRACTITIONERS CRAFT POLICY RECOMMENDATIONS FOR THE WILDLAND FIRE MITIGATION & MANAGEMENT COMMISSION.
