This is a common application for the following scholarships:

The **Julie Diamond Memorial Scholarship** was established in 2021 to honor Julie Diamond upon her retirement as OJCF's President & CEO. Soon after, Julie passed away and the fund very quickly grew to more than \$100,000.

The **Rebecca and Sada Tarshis Memorial Scholarship** was established in 2002 through a legacy gift from the Tarshis sisters to provide tuition assistance to Jewish students for higher education.

The **Gus and Lola Rosenblatt Memorial Scholarship** was created through the estate of Lola Rosenblatt for Jewish male identifying students from Oregon, attending school within Oregon.

The Lester & Annette Goldschmidt Hillel Scholarship was established by the Goldschmidts' children. To be eligible for one of these two \$1,800 scholarships, a student must be a Jewish resident of Oregon and attend the University of Oregon.

The **Singer Foundation Scholarship** is intended for Jewish individuals who are graduates (or the equivalent) of public high schools in Oregon for use in pursuit of full-time post-secondary education. Recipients can renew the scholarship automatically for up to three additional years of full-time study, provided the recipient maintains a 3.0 grade point average.

The **Arthur P. Krichevsky Memorial Scholarship** was established through a bequest from Mr. Krichevsky to further Jewish education.

*The majority of Krichevsky scholarship funds will be allocated to day school support, provided directly to schools, not to individual students.

Please note, priority is given to applicants who demonstrate financial need; however all are welcome to apply. Your Student Aid Index (SAI) is required to be considered for scholarships

and calculated using the information you provide on your Free Application for Federal Student Aid (FAFSA®) form. Your SAI will be listed on your FAFSA Submission Summary. If needed, you must provide income verification if requested by OJCF. The office will be in contact if additional information is needed.

A completed application will include:

One letter of reference received by March 29.

- This must be from a staff member or lay leader of a Jewish organization. Examples of lay leaders are educators, youth advisors, and board members.
- You will request this by sending an email through our system.
